NOTES

Mead Data has entered into a Complementary Marketing Agreement with IBM. Marketing efforts under this agreement will begin on September 1, 1983 and it is planned that the IBM hardware will be capable of accessing Mead's databases nationwide in the fourth quarter of 1983.

NOTES (CONT'D)

Mead also announced that in mid-July a controlled market introduction will begin in Washington, D.C. whereby users of IBM 3101 and the Tele-Video 950 terminals will be able to access Mead Data Central's information services. This introduction will be expanded to other major cities by the end of 1983 and may include other terminals, including the Hazeltine 1520.

OUTGOING PRESIDENT'S LETTER

NOCALL continued its growth in membership during the 1982/83 year. With over 160 members, we have offered a variety of programs and meetings to our members.

In November 1982 we held four concurrent workshops at the Faculty Club, University of California, Berkeley. The topics covered were: Stress Management, Automation of Law Libraries, Resource Sharing and The Impact of TEFRA.

In January 1983, NOCALL convened at The Lobby Restaurant in Sacramento for a luncheon meeting and an address by Gary Strong, California State Librarian. Tours of the newly renovated Capitol Building and the State Law Library were made available for interested members after the meeting.

As a result of our annual elections our new officers are: Gail Fleming Winson, Vice-President/President-Elect; Sue Welch, Secretary; Lynn Lundstrom, Treasurer.

Through NOCALL the law librarians of Northern California have been able to develop professionally and maintain social contact with one another. We look forward to a future of continued growth and professional enrichment.

MINUTES OF THE PREVIOUS MEETING

Linda also reported that she had received annual reports from five NOCALL Committee Chairs and that these annual reports, and any others submitted, would probably be printed in a special summer edition of the Newsletter. Linda said that all members of the Executive Board had received copies of the annual reports.

ELECTION RESULTS

Mary reported that the Executive Board met at Hastings on April 15, 1983 in order to count the ballots returned for the NOCALL election of 1983-84 officers. She reported that 110 ballots were returned out of 132 sent to active members. Two ballots were declared invalid. Both were mailed in one envelope; and neither was enclosed in an official ballot envelope. 108 ballots were counted with the election results being:

Mary asked for a motion to destroy the ballots. M/S/C.

COMMITTEE REPORTS

The President said that the quarterly report of the Treasurer which covers Institute finances speaks for the success of the Institute. In addition, she remarked that the well attended Institute on the topic of Bankruptcy at Fort Mason was blessed with good weather, given the rainy March San Francisco had had. The President thanked Nancy Carter and the Institute Committee for all their hard work in putting together such a good program and day of events.

Mary then took up the report of the Constitution and By-laws Committee and introduced Committee member, Liza Nicholson, who reported in the absence of Chair, Nancy Carlin. Liza said that the committee was charged with proposing a constitutional amendment addressing the resignation, or absence, of the Vice President/President-elect. Liza read the proposed amendment to the NOCALL Constitution (Article V, Section 4). She said that the amendment would be published and sent to members, and that the amendment would be on the agenda of the next General Business meeting in the Fall.

Mary then took up the report of the Municipal Codes Committee. In the absence of Committee Chair, Alice McKenzie, Mary reported that the committee is involved in a project of surveying California cities and counties to find out where their respective charters, codes, and ordinances are available. The committee needs volunteers to help in tabulating the survey results, Mary said. She encouraged interested members to contact Alice McKenzie at Brobeck, Phleger and Harrison in San Francisco. Mary reported that Alice had also contacted the Southern California Association of Law Libraries to see if SCALL would be interested in alternating the update of this project with NOCALL.

CONSTITUTIONAL AMENDMENT UNDER CONSIDERATION

This year's special election to fill the unexpected vacancy created when Nancy Carter resigned from her office as Vice-President/President-elect underscored the need for an amendment to NOCALL's constitution, which had not been worded to anticipate such a unique situation. The Constitution and By-law Committee's recommendation is to add appropriate wording to Article V Section 4 of the Constitution as printed below (added words are underlined).

Adoption of this amendment will be voted upon at the September 23rd Business Meeting.

CONSTITUTION AND BY-LAW COMMITTEE ANNUAL REPORT

This committee looked into possible changes to either the Constitution or the By-laws regarding succession to office. A proposed constitutional amendment was introduced at the May business meeting. It is now being published in the Newsletter so that all members can review the matter.

PROPOSED CONSTITUTIONAL AMENDMENT:

Art V Sec 4 to read:

In the event of the disability, absence or withdrawal of the President, the title, duties and obligations of the office shall be assumed by the Vice-President/President-elect, who shall then serve until the end of his or her term as President. A special election shall be held to fill the office of Vice-President/President-elect upon the assumption of the office of President by the Vice-President/President-elect or for any other reason of vacancy.

ANNUAL REPORT OF THE MUNICIPAL CODES COMMITTEE

The Municipal Codes Committee has had a very productive year. Our first meeting was held September 24, 1982 and at this meeting we decided that we needed to track out which depository libraries received which codes from the cities and counties of California. Muriel Hoppes submitted a list of the codes received at the State Law Library and the Institute of Governmental Studies sent us a list of the items that they receive. Our results showed us that the publications from the cities and counties were not being sent to these libraries in a consistent or complete manner.

At our October 22nd meeting we decided to ask the Board if they would allocate the monies for a survey of all the cities and counties in California to find out where their charters, codes and ordinances were available.

The Executive Board agreed to our proposal and offered some suggestions which we agreed upon. At our January 28th meeting the Committee drafted the cover letter and questionnaire. The letters and questionnaires were mailed on April 25th and the results will be tabulated this summer.

After the Committee has tabulated and printed the information, the Committee will have a publication available for each of the NOCALL institutions. The Committee feels that an institute or workshop should be held next year to complement this handout so that the librarians will have a better understanding of municipal and county government. The Committee also thought that the chapter could sell copies of this project to other libraries by advertising our product in the SCALL, AALL, and CLA newsletters.

It is the general feeling of our Committee that this survey is very important and should be updated periodically by SCALL or NOCALL so that the law librarians in the state can depend upon this information.


