Business Meeting Friday, September 24, 1982 U.C./Hastings College of the Law

The President, Mary Hood, called the business meeting to order at 4:15 P.M.

#### MINUTES OF THE PREVIOUS MEETING

The President announced that the minutes from the previous general business meeting at Stanford University on May 19, 1982, were printed in the July-August, 1982, NOCALL Newsletter, and asked for a motion to dispense with the reading of the minutes. Nancy Burrill, NOCALL Treasurer, 1981-82, was recognized by the President, and she made the following corrections to the "Treasurer's Report" as published in the NOCALL Newsletter minutes (July-August, 1982; page 4): the sentence, "In fact, the workshops caused the expenses" should read as follows: "In fact, the workshops met the expenses." Nancy Burrill also corrected the last quarter report date to "May 31, 1982" indicating that the May 31 date was the end of the fiscal year for NOCALL, not "June 31", as had been quite mistakenly printed on page 4 of the newsletter under the heading "Treasurer's Report".

Linda Weir, Secretary, acknowledged that the minutes were so corrected. Mary Hood asked if there were any other corrections or amendments to the minutes as printed. There were no other corrections or amendments offered. The President announced that the minutes stood as reported in the newsletter with Nancy Burrill's corrections. A motion to dispense with the reading of the minutes was seconded and carried.

#### SECRETARY'S REPORT

The Secretary, Linda Weir, reported that as of September 23, 1982, NOCALL had a total membership of 131 members, representing 114 active members, 12 associate members and 3 student members. The Secretary reported that there were 22 new members of NOCALL registered for the 1982-83 membership year.

The President, Mary Hood, welcomed all new members attending the business meeting.

#### TREASURER'S REPORT

The Treasurer, Rolene Bailey, reported that as of August 31, 1982, the end of the first quarter, there were

105 membership applications, at \$15 each, and 3 student membership applications, at \$5 each, received for a total first quarter income of \$1590. Expenditures for the first quarter were reported as follows:

Newsletter expenses - \$46.25; Postage for membership renewal notices - \$28.00; Filing fee for renewal for non-profit organization status - \$2.50; Flowers for Joanne Block - \$44.73; Expenses for May 19, 1982 meeting - \$164.08.

The Treasurer reported the balance of funds as of August 31, 1982, to be \$4,848.31. The Treasurer asked if there were any questions. There were no comments on the Treasurer's Report, and the President called for a motion to accept the report as read. M/S/C.

4. Automation in the Law Library. Linda said that questions, comments or suggestions from the membership were invited by the Education Committee members.

#### 2. Institute Committee

The President reported on behalf of Nancy Carter, Vice-President/President-Elect, and Chair of the Institute Committee, who was unable to attend this general meeting. Mary Hood announced that the 3rd Annual Institute would be held in San Francisco at Fort Mason on Saturday, March 19, 1983, and that the topic would be Bankruptcy.

#### 3. Placement Committee

#### NEW BUSINESS

The President conveyed the willingness of the Executive Boards of both Western-Pacific and Northern California AALL chapters to have a joint chapter breakfast at the 1983 annual AALL meeting in Houston. After a brief discussion, a motion in favor of a joint chapter breakfast with WESTPAC was introduced and by unanimous consent, carried.

The President reported that the Conference Manager of the San Francisco Hilton contacted our organization to ask if NOCALL would be interested in hosting the 1989 AALL annual convention. Mary said that bids for the 1989 convention will be asked for in November, 1983. Noting that a decision was not needed immediately, Mary put forth the request as a topic of discussion, with an eye toward appointing a committee to assess the matter. A general discussion followed with no motions put forward for consideration.

The President asked if there was any other new business to report. Alice McKenzie (Brobeck, Phleger & Harrison) was recognized by the President. Alice wanted to know if the members present were still interested in having new court rule information compiled by the Private Law Library Association of San Francisco published in the NOCALL Newsletter. There was a very definite interest expressed by the members, as well as appreciation that the Private Law Library Association was publishing the new court rule information in the NOCALL Newsletter.

The President expressed her thanks to the Hastings College of the Law and Library Staff for the use of the facilities. Members were invited to tour the Hastings Law Library and to meet for a Social Hour.

A motion to adjourn was made, seconded and carried at 4:45 P.M.
