

COMMITTEE REPORTS 1984-1985

For economy of space the following reports are excerpted. For full reports, contact the Committee Chairs.

AUDIT AND BUDGET COMMITTEE (Judy Janes, Chair)

The Audit and Budget Committee reviewed the financial records, journals, bank statements, and treasurer's reports for 1983-1984. All documents were in order and the beginning balance as of June 1, 1984, \$4,164.20 was confirmed.

The budget projections for NOCALL's 1985-1986 activities shows a net operating loss of \$1,500. Expenses for printing the newsletter, the directory, design and printing of the membership brochure, as well as \$1,000 for the Grants program have sharply increased the expenditures projected for next year.

The projections do not, however, take into account the cash balance on hand of \$5,500 and that the workshops and institutes have generated income of \$2,602.30. Assuming this trend continues there appears to be no special reason for concern regarding the budget projections for 1985-1986.

The Committe's recommendation is the following: (1) The chair for the next year's committee should be selected from the present year's committee membership if there is a willing candidate and (2) A member of the Executive Board should serve ex-officio on the committee to assist in the preparation of the following year's budget proposal.

CONSTITUTION AND BYLAWS COMMITTEE (Al Lewis, Chair)

The Committee reviewed last year's Annual Report and a letter from AALL Executive Director, William Jepson, concerning The AALL Model Chapter Bylaws. As a result of his suggestions, the Committee drafted additions to NOCALL's Bylaws on: (1) antidiscrimination, and (2) submission of amendments to the AALL Committee on Constitution and Bylaws for review.

The Committee also drafted an addition to the Bylaws after considering Gail Winson's request to amend the life membership provision so that prior membership in WESTPAC counts towards NOCALL life membership.

EDUCATION COMMITTEE (J. Paul Lomio, Chair)

The Committee sponsored the 1984 NOCALL workshop. The topics were: (1) Using a Microcomputer in the Law Library, (2) What a Bibliographic Utility (e.g. RLIN, OCLC) Can Do For Your Library, and (3) California Legislative Histories.

There were 91 registrants for the workshops which were held at the Red Lion Inn in San Jose. Dave Bridgman made all of the arrangements and things went very smoothly. The workshops were recorded on audio tapes which are available from Paul Lomio. Lorraine Rodich's suggestions for registration resulted in 8 new NOCALL members.

The Committee recommends an expanded role which could include additional smaller events for NOCALL and assisting the Institute Committee.

GRANTS COMMITTEE (William E. Benemann, Chair)

1984-1985 was the inaugural year for the NOCALL Grants Committee. The Committee consisted of William Benemann, Margaret Shediac, Michele Sullivan and Sue Welsh. Alan MacDougal substituted for Margaret Shediac for the rating of applications for grants to the national convention.

The Committee devised a tentative schedule, and guidelines for the selection of recipients. Guidelines and an application forms were approved by the Board.

Grants were awarded to Terry Heiser (Californial State Law Library), Esther Huston (California State Law Library), and Katherine Parkes (Alameda County Law Library) for NOCALL events. Two grants of \$500 each were awarded to Arturo Flores (UC Berkeley, Boalt Hall Law Library) and Janice Kelly (Hastings College of Law Library) for the AALL national convention.



LIAISON TO THE AALL RELATIONS WITH PUBLISHERS AND DEALERS (Manuel J. Koff, Chair)

There has been very little activity this year in the area of publisher/librarian relations. It may be that librarians are not experiencing problems or, more likely, problems are being resolved throught the AALL Committee. In view of this, the Committee recommends that the NOCALL Board consider abolishing the Liaison position.

The AALL Committee remains the most effective vehicle for publicizing and resolving disputes, and for keeping advising members about such issues as publishers' invoicing, pricing, return, and supplementation policies. (Editor's note: the Committee has been abolished.)

MEMBERSHIP COMMITTEE (Nancy Lewis and Martha Mille, Co-chairs)

The Membership Committee, which also included Jo Caporaso and Cella Mitchell, designed and produce a membership brochure. (Editor's note: the brochures are available from the new Membership Chair, Nancy Carter.)

The Committee members established a liaison with UC Berkeley and San Jose State University library schools, where they gave three presentations. Over half of the 1984-1985 new student memberships were received after these presentations.

Over forty-nine welcome letters were sent to new members, and many membership applications were sent to potential members.

The recommendation for next year is to establish an internship program to respond to the many inquiries and interest in this kind of program that were received by the Committee.

NEWSLETTER COMMITTEE (Teresa Oppedal and Janice Kelly, Co-chairs)

The 1984-1985 editors, assisted by Laura Peritore and Mary

Glennon, published six Newsletters. As of the fifth issue, March/April 1985, \$2,138.54 was spent.

The only major change for the newsletter this year has been bulk mailing. This has dramatically reduced the cost of the mailing but has made date of receipt of the newsletter highly unpredictable. For newsletters containing time sensitive information, the Committee indicated that first class mailing is necessary.

NOMINATING COMMITTEE (Linda Weir, Chair)

The Nominating Committee completed its charge in January, 1985, upon presenting a slate of candidates to the Executive Board. Linda Weir, Lynn Lundstrom, and Eileen Norris are very grateful to the NOCALL members who agreed to be candidates in our recent election.

PLACEMENT COMMITTEE (Trish McCurdy, Chair)

Ruth Girill, Eileen Norris, and Trish McCurdy posted invitations to potential employers to use NOCALL's placement services. Another mailing was sent to small law firms, local bar associations, and law schools.

The Committee also provided job listings over the telephone, at profesisonal meetings, by appointment and through the NOCALL Newsletter. Resumes were also loaned to employers on request. In addition, announcements of NOCALL's placement services were posted at the University of California Placement Center and the San Jose State University School of Library Science.

Over the course of the year, the Committee received 22 professional resumes, 9 library technician's resumes, 34 professional job listings and 25 library tehnician's job listings.

PUBLIC ACCESS TO LEGAL INFORMATION COMMITTEE (Katherine Henderson)

This year, the Committee concentrated its efforts on improving public access to legal information in the Sacramento and San Francisco Bay Areas by conducting workshops in legal research for public librarians.

The four Sacramento Committee members (Katherine Henderson, Shirley David, Barbara Elbrecht, and Chizuko Kawamoto) conducted a successful three hour workshop for public library reference librarians from the Mountain-Valley Library System.

The three San Francisco Committee members (Scott Pagel, Marian Shostrom, and Karen Toran) explored the possibilities of conducting workshops with the San Francisco Public Library and the Bay Area Information Systems.

The Committee's goal is to continue to provide training in use of legal materials to public librarians. To this end, the Committee announced the availability of their workshops in the California State Library Newsletter.


UNION LIST COMMITTEE (Mary Staats, Chair)

The committee consists of law firm librarians who had undertaken the project of publishing a new edition of the Private Law Library Association of San Francisco Union List. When the PLL and NOCALL voted to join forces, the NOCALL Union List Committee was born. Soon after, the PLL contributed \$500 to the union list project.

Once the finished product is received from CLASS, copies will be made and distributed. The estimated price is \$50 per copy. The Union List should be available by the first of June (editor's note needed here).

Maureen Sirhall deserves thanks for her support and wisdom gained from experience with the PLL Union List as does Lynn Brazil for temporarily taking over for Maureen and Mary. Barbara Friedrich, Manuel Koff, Joan Loftus, Debbie Martin, Trish McCurdy, Eileen Norris and Teresa Oppedal also provided dedication and diligent work.

The Committee suggests investigating other vendors to compare quality, pricing, turn around time and editorial control before the next edition.




Joy Scott reports Blase, Valentine & Klein is moving to their new office building located at 1717 Embarcadero, Palo Alto, CA 94303.
