

COMMITTEE REPORTS



MEMBERSHIP COMMITTEE

On March 13th Jo Caporaso, Nancy Carol Carter, Martha Mille, and Cella Mitchell, representing the NOCALL Membership Committee, made a two-hour presentation to U.C. Berkeley Library School students as part of a current awareness program. The presentation was entitled, "The Value of Joining Professional Organizations."

The program began with individual introductions, and brief descriptions of our law library and professional experience. Topics discussed included "Options Available to Law Librarians," "Requirements for Employment and Courses Helpful for Preparation as a Law Librarian," "What we Look for in a Job Applicant," "Resume and Cover Letter," "Interviewing Techniques," and a "History of NOCALL."

Cella Mitchell and Nancy Carter led the discussion, and we all contributed our own opinions and related experiences.

We enjoyed telling future librarians about our organization, and wish to express our sincere thanks to Nancy Carol Carter for volunteering her time and contributing her valuable experience to help make the presentation a great success. Nancy Lewis, co-chair of this committee, planned the presentation but due to illness was not able to attend.

The Membership Committee looks forward to a repeat performance on April 10th at San Jose State University, Division of Library Science. We will be speaking to the Special Libraries class.

The membership brochure has been approved by the Executive Board and we hope to have the finished product ready for the May business meeting.

GRANTS FOR NEW YORK CONVENTION

The NOCALL Grants Committee will be awarding two \$500 grants to NOCALL members to help defray the cost of attending the AALL convention in New York City in July. Grants will be awarded on the basis of financial need, proven ability and promise of future usefulness and continued contribution in the law library profession.

Recipients who are simultaneously awarded a grant by the national organization for travel to the annual convention may not accept both grants.

An application for the NOCALL grant is included with this newsletter. The application and two letters of recommendation should be sent to Committee Chair William Benemann at Golden Gate University. Applications must be postmarked no later than May 1, 1985.

PUBLIC ACCESS TO LEGAL INFORMATION COMMITTEE

The four Sacramento members of the Committee recently conducted a successful three-hour workshop on legal research for public library reference librarians belonging to the Mountain-Valley Library System. The workshop was held at the request of the MVLS Forums Subcommittee on February 8th in the Auburn-Placer County Library. Thirty-one librarians attended.

According to the Reference Forum Evaluations, the most useful part of the program included the presentations on primary and secondary sources of the law, the Federal and California judicial systems, the Federal reporting system, lawyer referral services available in Sacramento, and the discussion of popular titles for small libraries. The panel discussion on the legal reference interview, the question and answer period, and the handouts were also appreciated. Suggestions were made to spend more time on discussions pertaining to the law collections for small libraries with limited budgets, and how the small library can direct patrons to reliable sources of information.

The fifth annual NOCALL Institute was held March 9, 1985 at the Hotel El Rancho Racquet Resort in Sacramento. The rain storms left us Friday night and we had a gorgeous day. Over 70 registrants attended the all-day conference on labor law. Alice McKenzie, chair of the Institute Committee, made opening remarks and introduced the speakers.

Donald H. Wollett, professor at McGeorge School of Law, gave an excellent introduction to labor law. Prof. William B. Gould IV, followed Prof. Wollett, with a presentation on employment-at-will.

Bob Berring, Vice-President of AALL, was the featured luncheon speaker. His grievance story was hilarious. He also encouraged all members to become active in AALL.

Following a delicious lunch, Mr. Donald Connors, a partner at Brobeck, Phleger & Harrison, spoke on labor arbitration. The comparable worth panel discussion including Mr. Douglas Gordon, from the California Chamber of Commerce, Mr. Leo Mayer, President of CSEA and Patricia Campbell, an attorney representing CSEA in its lawsuit against the State of California on pay adjustment issues, was very informative. The program concluded with an excellent bibliography presented by Janice Kelly and Joanne Block.

The members of the Committee who organized this very successful Institute were Alice McKenzie, Shirley David, Marian Sawyer, Marilyn Josi, Al Lewis, and Beth Owens. They did an exceptional job.

SUPREME COURT OF TEXAS DOCUMENTS AVAILABLE ON MICROFICHE

In the fall of 1983 the Texas State Library in collaboration with the State Law Library began microfilming and reproducing on 24x microfiche all of the documents filed in each case before the Supreme Court of Texas. The microfiche for each case contains a caption with the Supreme Court of Texas docket number, the style of the case, and a notation showing from which court of appeals the case came. The documents themselves are arranged on the fiche in the order in which they were filed in the Supreme Court of Texas.

To improve access to these documents, the State Library is publishing indexes to the Supreme Court cases for which microfiche is available. These indexes have proven a useful tool even for researchers who do not own the microfiche, because the indexes are arranged by Supreme Court of Texas docket number and by court of appeals citation as well as the standard petitioner and respondent case name tables.

Paper copies of the indexes to the cases decided by the Court during the period September 1983 through July 1984 are now available. A mid-term index, covering September through February, was published on a limited basis this past year, and will be again available in March, 1985. Copies of the indexes are also available on microfiche.

The Texas State Library will sell the microfiche for the indexes or for individual cases on request. In addition, standing orders to receive all of the cases films, about 90 per month, are also accepted.

The cost for standing order customers is 75 cents per fiche, invoiced with each monthly shipment. Orders for individual cases or for the indexes on fiche are also filled at 75 cents per fiche, with a three dollar handling charge per order. CALIFORNIA COUNTY LAW LIBRARY BASIC LIST

The State Law Library recently published a 1984 edition of the California County Law Library Basic List. The first edition of this publication was issued in 1961 and was based on personal visits by, then State Law Librarian, Carleton Kenyon to virtually all county law libraries. The early editions reflected titles in the collections of those libraries. With the 1976 edition, recommended titles were noted. Those recommendations were in relation to the size of the library, in terms of the number of attorneys in the county, and were made by the State Bar Committee Re County Law Libraries. In addition, the Committee noted alternative titles in a number of instances.

The 1984 edition continues the policy established in the 1976 edition of noting recommended titles for county law library collections. However, in the new edition, the recommended titles are those essential for all county law libraries, regardless of size, to have in their collections. The new edition also has a significantly broader subject coverage, as it includes all of the California Continuing Education of the Bar book titles, as well as all titles in the West Nutshell series and the Nolo Press self-help titles.

The first sections of the Basic List cover Research Aids (legal bibliographies, directories, for example); United States materials (statutory and administrative materials, court reports, legal encyclopedias, national reporter system, etc.); California materials (statutory, administrative and court reports): and Periodicals and Newspapers. The fifth section is a subject arrangement of basic legal treatises.

In addition to the bibliographic data, as appropriate each entry notes the most recent supplement, purchase price, annual upkeep cost and shelf space required.

David Bridgman reports Stanford is finishing a four week WESTLAW/LEXIS joint training session. Five training terminals for each system were available for approximately 150 first year law students.




