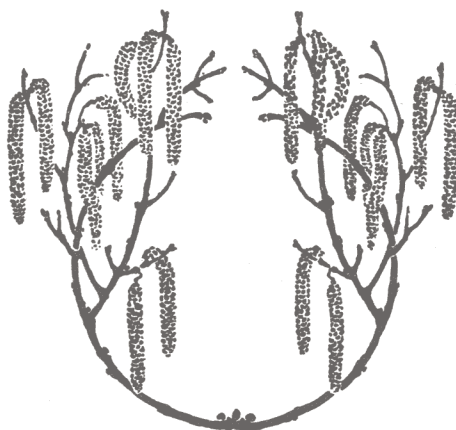

NOCALL BUSINESS MEETING MINUTES

Friday, May 16, 1986
McGeorge School of Law

Alice McKenzie, President, called the meeting to order at 4:15 p.m. She thanked Katherine Henderson and McGeorge School of Law for providing a beautiful facility, announced the location of the dinner following the meeting and reported that 35 members were attending the meeting.

Alice announced that the Secretary had distributed the minutes from the previous business meeting held September 27, 1985 and that these minutes were published in abbreviated format in the NOCALL Newsletter. (See volume 6, number 3) Noting the limited amount of time to read the minutes, she asked if there were corrections. There were no corrections and the minutes were approved.

Secretary's Announcements: Trish McCurdy remarked that NOCALL's membership is consistently growing. There were 242 members to date compared to 220 last year and 195 the year before. The very active Membership Committee has contacted librarians in distant counties with the result that the Monterey and Tulare County law librarians, some from the Courthouse in Placerville and a firm librarian from Fresno are included in our membership. Student members number 15, associate members number 37 and the active membership was 190. Trish reported that renewal forms and letters would be sent the week of May 27. Forms should be returned by July 31. A prompt return will greatly assist the new Secretary in the creation of the NOCALL Directory and should be sent to the new Treasurer who will be announced later. His address will appear in the letter accompanying the renewal form.

NOCALL BUSINESS MEETING MINUTES continued....

Treasurer's Report: Scott Pagel reported that NOCALL has had a very good year. The balance on June 1, 1985 was \$4,4477.87. Dues brought an income of \$3,455. The October workshop with Westpac yielded \$1,096.07. Sale of the Union List brought \$2,810 and a profit of \$553.68. At the end of this fiscal year NOCALL had \$5,605.14. (The treasurer's report is printed in this issue of the Newsletter.)

Committee Reports: (The committee reports are printed in the next issue of the Newsletter. The contents are not repeated in the minutes.)

Archives. Jo Caporaso, Chair, read the annual report adding that Margaret Shediak come forward with a file dealing with the early years of NOCALL and that Jo had contacted the AALL Archives regarding missing issues of the NOCALL Newsletter.

Audit and Budget: Joy Avery, member, read the annual report.

Constitution and Bylaws: Stuart Sutton read the annual report.

Education: Michele Sullivan, member, read the annual report.

Grants: Shirley David, Chair, read the annual report.

Membership: Michael Jones, Members, read the annual report and listed the committee's members including Brent Bernau, Nancy Carol Carter, Chair, Donna Martinez, Louise Roysdon and Ruth Stevenson.

NOCALL BUSINESS MEETING MINUTES continued....

Alice McKenzie noted that Trish McCurdy has had four part membership forms printed with one copy to go to the Membership Committee.

Newsletter: Susan Kuklin read the annual report.

Nominations: Muriel Hoppes, Chair, read the annual report. She added that a supplemental report was prepared including an outline of instructions for the 1986-1987 committee and recommended that the useful list of committee members be expanded to include those serving on the Institute Committee.

Placement: Peg LaFrance, Chair, amended that annual report to reflect recent data. (The amended report will be published in the next issue of the Newsletter.)

Public Access to Legal Information: Katherine Henderson, Chair, read the annual report. Additionally, she recognized the Sacramento members present and added that her two years as chair have been a pleasure.

Union List: Mary Staats, Chair, read the annual report. The committee sold 85 copies of the Union List, collecting \$2,810.

Liaison with the Association of Legal

Administrators: Alice McKenzie announced that the ad hoc committee, chaired by Ann Borkin, will hand in a report later. The committee reviewed the job descriptions used by the Association of Legal Administrators salary survey of law firms, making some changes in the librarian, assistant librarian and library assistant positions. Alice was able to get the salary surveys for assistant librarians and library assistant positions; however, the legal administrator in her office would not provide the survey for librarians.

New Business: Peg LaFrance announced the availability of the salary surveys prepared by the Association of Legal Administrators for the local region and the Special Library Association's San Andreas Chapter.

Election Results: Alice McKenzie announced that of the 182 ballots distributed 142 were returned and 138 valid ballots were counted. Sharon French was elected Vice-President/President Elect, Jo Caporaso was elected Secretary and Manuel Koff was elected Treasurer. A move to destroy the ballots was requested. Shirley David so moved and Peg LaFrance seconded it.

Alice McKenzie congratulated all the committees on their work. NOCALL will miss Scott Pagel who has accepted a position at Columbia University and will be moving to New York. Alice thanked Trish McCurdy for producing the Directory and taking detailed minutes, Gail Winson for providing valuable experience, and David Bridgman for producing a fine institute. She presented the gavel to President David Bridgman. David accepted with thanks and announced he has sign-up lists for committees and that the Fall Business Meeting will be held at the Stanford Law School Faculty Club on September 26. All applauded Scott Pagel for his fine contributions. At 5:06 David Bridgman adjourned the meeting.



SANTA CLARA COUNTY LAW LIBRARY PARKING

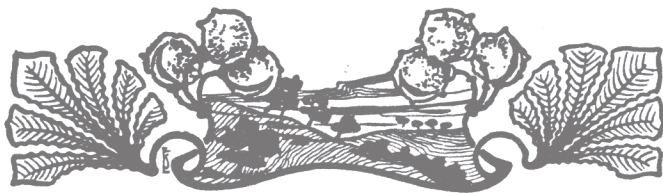

PLL PROGRAM FOR AALL WASHINGTON, D.C. CONFERENCE

Nuchine Nobari, PLL SIS Chair-Elect, reports on the July 1986 Program in Washington D.C. and Planned Projects: "Following is a list of programs as scheduled in the order in which they will appear. While most of the speakers are law librarians with several years of active participation at the local and national level, some outsiders such as Stephen Glasser, Representative Douglas Barnard, James E. Scott, Dennis O'Tool and Gina Resnick will bring to us a refreshing view of our concerns. Steve Glasser is president of Harcourt Brace Jovanovich. His company has been publishing legal books, newsletters and newspapers since 1978. Gina Resnick the former librarian of Milbank Tweed, Hadley and McCloy (oh yes, there is life after librarianship) is now the administrator of the Washington, DC office of Milbank Tweed.

"'Management of Legal Documents, Briefs, Memos and Other Court Papers,' will be given on Monday, July 7, 2:30 pm - 3:55 pm. Martha Goldman, Manager of Information Services at CBS, Inc. Law Department will be chairing the meeting. Martha's experience includes 10 years of private libraries and two years of records management. Martha is presently responsible for the operations and development of both the library and the Records Department. The panel members are: Ruth Ulferts, librarian at Reid and Priest, George Kirlin, Information Manager at Van Ness, Feldman, Sutcliffe, Curtis and Levenberg and Arlene E. Bronstein, Records Manager at Davis Polk and Wardwell. They will cover the 'how-to-do-good' aspects of setting up 'files' and managing both the library and records department.

"The third program on 'Issues in Federal Banking Law,' will be chaired by Kathleen Martin. The panelists, Representative Douglas Barnard, member of House Banking, Finance and Urban Affairs Committee, James E. Scott, senior attorney of the Federal Reserve Board and Dennis O'Tool, senior Federal Legislative Counsel of the American Bankers Association will discuss the regulatory and statutory aspects of banking.

"The plans for the Sunday morning program are still being developed by Helen Burwell. As scheduled, the report on the responsibilities and going salaries of library jobs will be the focal point of this program. Each chapter will be contacted for comments and contribution.

NEEDS INPUT FOR THE ANNUAL CONFERENCE

Helen Burwell, Chair of the Sunday Morning PLL program, will focus on using salary surveys as a tool and on various aspects of job descriptions - how to write them, how to use them, and how PLL members are using them to expand their responsibilities. FREELANCE BOOKBINDER NABBED IN DENVER

AALL's SWALL Chapter announced in their newsletter that a man who had been taping up damaged book bindings, and in some cases changing the book's call numbers to what he felt were more appropriate ones, has been charged with "harassment, criminal tampering, defacing public property, and unlawful conduct on public property." Thomas Winslow, a self-appointed library critic, has been operating his repair service at the Auraria Library in Denver and the University of Colorado at Boulder. According to the Auraria director, Mr. Winslow was arrested at both libraries. The culprit could draw up three years in jail and fined up to \$3500 for his deeds.

What is the significance of the gold dash on the spine of AmJur 2d?

As part of its process of continually updating Am Jur 2d, Lawyers Cooperative and Bancroft-Whitney issue revised volumes of the encyclopedia as needed. When a volume is revised a gold dash is placed in the back panel of the spine, underneath the subject and sections covered by that volume. If the revision results in splitting the volume in two or more new volumes, the new volumes will be labeled with and A and a B, if necessary. For example, the subject Bankruptcy is in volumes 9 and 9A. When first published, a volume with an A or a B will not have a gold dash; however. If it is subsequently revised and reissued, it, too, will sport the dash. (from the SWALL Newsletter)

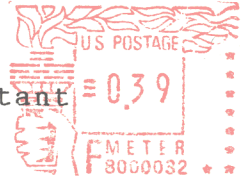
