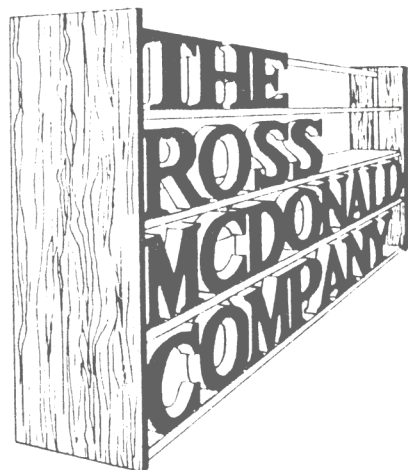

LEGISLATIVE HISTORY RESEARCH

HOW A BILL BECOMES A LAW IN CALIFORNIA

And The Records That Are Most Commonly Generated During That Process

STEP 1: The measure (generally a Senate Bill or Assembly Bill) first goes to a policy hearing in the house of origin. Records generated: committee consultant bill analysis, letters and position papers (frequently useful in tracing the purpose of amendments). Note: The measure may be amended throughout the legislative process, generating various bill versions and possible explanatory correspondence.

STEP 2: If there is state fiscal impact, the measure must pass the fiscal committee in the house of origin. Records generated: Legislative Analyst and Department of Finance analyses (also a Ways and Means Committee analysis in the Assembly), letters and position papers.

STEP 3: The "floor" of the house of origin is next. Records generated: floor analyses, letters and position papers.

STEPS 4 - 6: Leaving the house of origin, the bill then moves through similar steps in the other house (same types of records generated). STEP 4. A policy committee. STEP 5. A fiscal committee, if appropriate. STEP 6. The "floor."

STEP 7: If the bill was amended in steps 4 - 6, it returns to the floor of the house of origin for "concurrence" on amendments. (Nonconcurrence will result in a joint house conference committee whose recommendations must be approved on the floors of both houses. More than one conference committee may be necessary.) Records generated: floor analyses, conference reports, position papers.

STEP 8: The bill is then enrolled and sent to the Governor who may approve (with or without a signature) or veto it. (The Legislature may override the veto). Records generated: enrolled bill reports by various state agencies and correspondence to the Governor. The bill is chaptered by the Secretary of State and becomes law on the next January 1st unless otherwise specified. Urgency bills take effect immediately.

The Institute will be held on Friday, March 16, 1990, at the Claremont Resort and Tennis Club. A variety of issues will be addressed including: What type of legal research skills need to be taught? To what extent should librarians be involved in the legal research training process? These and other topics will be presented from the perspectives of firm, academic, court and county law librarians. Faculty will include Jim Martin, Crosbey, Heafey, Roach and May, Bob Berring, Myra Saunders, Linda Spath, Molly McCluer, Marlene Harmon, David Bridgman, Yvonne Boyer, and others. Maureen Sirhall will prepare a bibliography for the program.

A mailing list including a more complete description of the Institute, a registration form, and a NOCALL grant application form will be distributed in mid-January. The registration deadline will be February 15, 1990.

CA NETWORKING TASK FORCE REPORT

A California Library Network Planning Retreat was held at the Westin Hotel, San Francisco Airport December 6-8, 1989. Over 100 representatives from library organizations attended.

Wednesday morning the Steering Committee met to adopt the mission statement, network principles, and network services and functions. This document had been developed during a series of meetings of various groups, and public meetings during 1989. It is the first document of a three phase planning process.

The adopted mission purpose is to respond fully to California's information needs by the interaction and cooperation of all types of libraries throughout the state. The program is to develop regional multi-type library networks. Principles of network design included equity in governance, voluntary participation, fair and reasonable access with appropriate protocols, performance standards, and sufficient funding. Definitions of the network principles were adopted. Services provided by the regional and statewide networks could include but not be limited to:

- * Resource Sharing
- * Services to the Underserved
- * Interlibrary communications, delivery and other linkages
- * Statewide communications, delivery and other linkages
- * Network Products
- * Human Resource Development
- * Administration and Management
- * Conservation and Preservation

* Public Relations and Marketing

The representatives from the steering committee, resource libraries committee and planning committee spent the following two days preparing the decision point papers for the second phase of network development involving membership eligibility, network organization and governance. Using a consensus based planning process, work groups were assigned the tasks of:

- * defining membership criteria
- * developing model organizational structures and listing the pros and cons of each structure
- * suggesting the type of governing body for each model

The draft documents resulting from the retreat will be available by mid-January and distributed to the library community. NOCALL president Virginia Kelsh will serve as our representative on the steering committee for the 1990 calendar year. She will be looking for a volunteer to serve on the planning committee.

I feel strongly that as many law librarians as possible should be involved in this multi-year network planning process for three reasons. First, it is to our advantage to be offered participation in multi-type networks if they can provide additional benefits to the informal law library networking that we now use. Second, the more law librarian voices there are at these meetings the more they will be heard. Finally, the next long-range plan for Title III LSCA funding will be based on the networking task force's recommendations. Law librarians' requests for a share of that funding have always been turned down in this state. Working within a multi-type network may be the route to develop grant proposals that will meet the requirements.

There are also personal reasons for being involved in a process that brings us together with other librarians. At the retreat I got to know Judith Runyon, SCALL president better. I met the Chapter coordinator of the state corrections libraries

who requested 20 NOCALL membership applications. I spent a lunch hour with the Auburn-Placer County Librarian discussing ways to improve their county law library which is housed in their public library.

The schedule for 1990 is as follows: a March meeting for the committees to review the documents drafted at the December retreat and prepare for the public meetings that will be held around the state in May or June. The planning committee will review input from the public meetings and prepare the documents for approval by the steering committee and resource libraries committee at a retreat tentatively planned for October. If the governance and participation documents are approved the committee will prepare discussion documents for funding in 1991. The planning schedule has been carefully prepared so that the funding request will be made after the next gubernatorial election.

I am impressed by the State Librarian's attempt to include everyone who has an interest in multi-type library networking and by the organizational support of the State Library. Please contact Shirley David at (916) 440-6013 or Richard Leiter at (415) 399-8421 for copies of the Networking documents generated this year. You also can be added to the California Library Networking mailing list to receive all future documents directly by calling Barbara Will at (916) 332-0371.

I have enjoyed serving on the California Library Networking Taskforce Steering Committee during 1989 as your NOCALL representative.

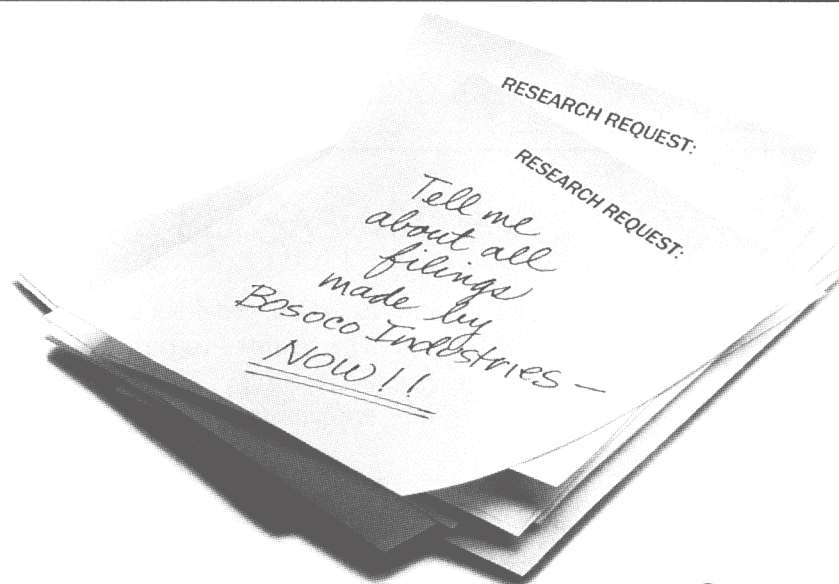
