### BEGINNING THE NEW YEAR

1990/91 promises to be another challenging year for NOCALL. There are a multitude of opportunities for member participation as committees set goals, and planning for major events gets underway. NOCALL already has the spotlight as the key chapter involved in local arrangements for the 1992 AALL Annual Meeting in San Francisco. Additionally, members are busy preparing program proposals now for the 1991 Meeting in New Orleans. ### MEAD SPONSORS LEGAL RESEARCH CONFERENCE FOR PRIVATE LAW LIBRARIANS

Thirty-five law librarians nationwide attended a conference this past spring on the topic of legal research instruction. Mead Data sponsored the conference offering a unique opportunity for law librarians to share their knowledge with each other on a wide variety of topics which comprise all aspects of legal research instruction.

Representing the Bay area were Rich Leiter of Littler, Mendelson; Nora Skrukrud of Crosby, Heafey; and Bob Berring, UC Berkeley who participated as faculty. Sandra Sawyer, Bronson, Bronson & McKinnon; and Mary Torres, Steefel, Levitt & Weiss were attendees.

There were a wide range of skill building topics covered. Examples included how to use Jury Verdicts Weekly, how to lecture effectively, in-house staff training, research techniques for partners, and associates, etc. It was reported that some law schools are allowing law firm librarians to meet with law students and assist in the instruction of legal research.

Marie Wallace, O'Melveny & Myers, chaired the conference, which was a great success. Law Librarians returned to their libraries with new and substantive techniques for starting or improving a research instruction program.

### SALARIES LAGGING FOR LAW LIBRARIANS

A recent article in Of Counsel, Volume 9, Number 12, June 18, 1990, points out that law librarians are paid less than other support staff working with attorneys. A survey conducted by Altman & Weil, Inc. which was sponsored by the American Association of Law Libraries, Private Law Libraries SIS, gathered data from 619 private law libraries.

Some of the data gathered reported that:

1. New lawyers were paid an average of \$45,410 annually, while chief law librarians with more than 20 years of experience earned an average of \$47,928.



2. Chief law librarians with a JD were paid an average of \$48,839, and those with a MLS averaged \$37,234.

3. Paralegals, working in large firms, made an average of \$27,888 annually, while regular law librarians with an MLS were making \$29,694.

To help explain this disparity, Dr. Robin Hegvik, survey coordinator at Altman & Weil, offered the reasoning that paralegals can bill for their work product, while law librarians cannot.

### FAIR USE OR COPYRIGHT INFRINGEMENT - NEWSLETTERS TARGETED

Proving copyright infringement cases can be very difficult, especially when people are used to copying portions of a copyrighted work for what under the law is considered fair use. A recent settlement, however, was reached in favor of Washington Business Information, Inc., for \$100,000 for an infringement claim involving the copying and disbursement of newsletters.

Federal law protects copyright material, and in cases of willful infringement it authorizes damage awards of up to \$100,000. Newsletter publishers offer rewards, of \$2,000 or more, for information leading to a successful infringement claim.

Newsletters are easily copied, because they are normally only a few pages in length. They often carry current, essential bits of information on very specific issues, and businesses often want to distribute copies quickly to many employees without paying for more subscriptions. Publishers report that copying infringements cut into their annual revenues by some 20 percent, and they are becoming more aggressive in protecting their work against copy infringement.

Subject newsletters are being read and used more by lawyers and judges, especially in dealing with specialized cases. Some legal newsletters are providing texts of otherwise unpublished trial opinions. The number and subject nature of legal newsletters has grown by phenomenal numbers, such that the infringement issue to publishers is now an economic one.

1. Welcome and Introduction

Virginia Kelsh, NOCALL President, welcomed everyone to the Annual Business Meeting and had all new members introduce themselves.

2. January 18, 1990 Business Meeting Minutes

A motion was made, seconded and passed to destroy the ballots.

Virginia thanked all the candidates who ran for the 1990/91 offices, remarking on what a good slate of candidates the membership had to select from.

5. Annual Committee Reports

Several of the Committee Reports were submitted in writing since the chairs of those committees were unable to attend the meeting. A motion was made, seconded and passed that Virginia present a summary of these reports to the meeting. 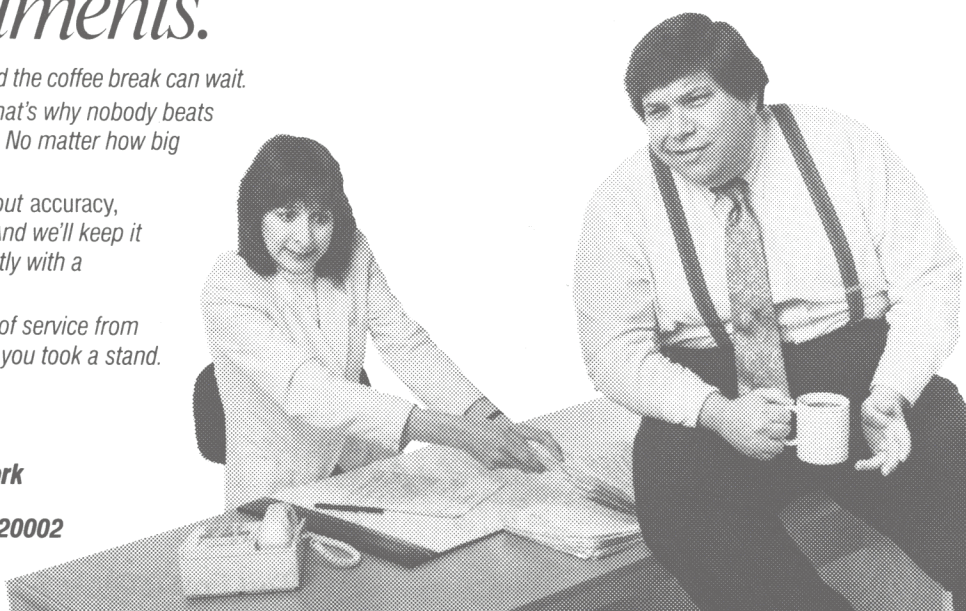

### CALIFORNIA LIBRARY NETWORKING TASK FORCE: PHASE II PLANNING

CA Library Networking Task Force*

Virginia Kelsh, representative to the CA Library Networking Task Force, represented NOCALL on the Task Force Steering Group at an all-day meeting in San Francisco on Friday, July 13, 1990. The Steering Group, composed of about 39 members representing public, school, academic and special libraries and library organizations, is charged with coordinating the development of the California multitype library network through a consensus-based planning process, and setting policy directions for the network and its development. The Steering Group is the policy-making group of the Task Force.

The Planning Group, to which Martha Mille is a representative for NOCALL, is the working body of the Task Force and is charged with drafting policy documents which are later reviewed by the Steering Group. A third body is the Serials Task Force Group. NOCALL member Todd Bennett has been attending these meetings to represent the law library viewpoint on serials issues. We represent you and your libraries, so if you have concerns, please contact us.

Last year, the Task Force completed Phase I of planning: adoption of the network mission statement, network principles and network services and functions. (See Shirley David's report in Jan./Feb. 1989 NOCALL NEWS, pp. 7-8). This year, Phase II planning focuses on membership eligibility, network organization, and governance issues.

Four open forums will be held during September. I hope many NOCALL members will attend these open forums where the Task Force's work to date will be reviewed and where membership eligibility requirements will be defined. Registration forms have not yet been prepared for these all-day meetings but the dates and locations will be as follows:

Laguna Niguel - Wednesday, September 12  
Oakland - Friday, September 14  
Manhattan Beach - Monday, September 17  
Sacramento - Wednesday, September 26

If you wish to attend, you could call Barbara Will at the CA State Library in Sacramento at (916) 445-2585, and ask for a registration form. They will be available in early August.

### CALIFORNIA CODE OF REGULATIONS DEPOSITORY STATUS UPDATE

In June, the Office of Administrative Law agreed to make the revised California Code of Regulations available for depository distribution. This reversal of the OAL's previous position came after an oversight hearing in the Subcommittee on State Administration of the Assembly Committee on Ways and Means. Lobbying and advocacy by California librarians - including a NOCALL letter-writing campaign - in turn preceded this hearing.

Under the agreement, 100 copies of the Code (the minimum required by the Library Depository Act) will be distributed. Full depositories (and a few selective depositories) will receive paper copies. Other selective depositories will receive microfiche. Because there are more than 100 depository libraries, the State Librarian has "rationed" copies among the selective depository libraries on the basis of interest expressed in response to a survey, as well as geography, population, and maximum public access. (Under a separate provision of the Government Code, county law libraries also receive copies of the Code.)

Although fiche is not the optimal format for distribution of the Code, and although the statutorily required 100 copies don't go quite far enough, the outcome of this dispute is a qualified victory for libraries concerned about access to government information. It has at least been established that the Code is covered by the Library Depository Act and must be distributed in some format. Thanks to all NOCALL members who participated in the letter-writing campaign for helping to bring us this far.

## AALL News

### LEGISLATIVE UPDATE PROGRAM AT AALL

Summarized from data distributed by the AALL Government Relations Committee at AALL.

1. Project Hermes. The United States Supreme Court will release its opinions electronically through a system called Project Hermes. New opinions will be downloaded from the Court's internal computer onto floppy disks. The disks will be loaded into the Hermes PC which, through 15 ports, will disseminate the opinions to commercial vendors. AALL asked the Court to assign a port on the Hermes PC to the GPO and after much negotiation, it appears that GPO will be designated the primary public access channel for the system.

2. HR 3849 (Government Printing Office Improvement Act). The bill seeks to clarify the role of the GPO and the Federal Depository Libraries regarding electronic publishing. As currently worded, the bill allows GPO production and distribution in any format, and to impose a cost sharing approach to the distribution.

AALL committee members have urged that government publications be broadly defined to include both electronic and non-electronic information formats, and that cost-sharing should be on a more flexible arrangement as needed.

3. Law Library of Congress. AALL strongly opposed a proposal to merge the Law Library of Congress into the general organization of the Library of Congress, thereby dissolving it as separate entity. Due to the strong opposition of AALL the Law Library will retain its autonomy.

4. State Department Bulletin. Without notice, the State Department announced that it would no longer publish the Department of State Bulletin, a major resource for treaty research and foreign policy statements. AALL and others urged the State Department to reconsider this decision.

Officials said that much of the Bulletin's information would be released in a new publication "Dispatch". The Bulletin was stopped because of budget limits. A new effort is being exerted to pressure the department to resume the Bulletin's publication.

5. S 1067 ( National Research & Education Network). This bill proposes the building of the National Research and Education Network - a national high performance computer network which will link computer users in libraries, academic institutions and government and industry. It proposes that there be at least one connecting in each state.

6. SJRes 57. (Permanent Paper Resolution). It is expected that the national permanent paper policy bill will pass the House in the last weeks of Congress. Considered non-controversial, it establishes a national policy to promote the printing of books and other publications of enduring value on alkaline, permanent paper.

### LEGAL INFORMATION SERVICE TO THE PUBLIC - SIS

The AALL Legal Information Service to the Public SIS provides an outreach function. Its purpose is to alert public users who are unaware that law libraries are resources available to them which the need for legal information arises.

Most of the section programs are offered at the local or regional level, and the SIS encourages chapters to organize programs to create local or regional clearinghouses of information to be made available to educate these groups. This past year the SIS developed law library policy guidelines for the dissemination of legal information to the public and a program presented at the AALL meeting in Minneapolis to help identify the type of information that should be provided to the pro se patron.

### CATALOGING SUPPORT SYSTEM COSTS - A STUDY

A recent study of cataloging support system costs appeared in the July-August 1989 issue of Library Technology Reports. The study was done by William Saffady, and documents that the costs for cataloging in RLIN average \$3.31 per title plus local labor costs are estimated to be \$7.28 per title. It is noted that the \$3.31 figure is comparable with those for other bibliographic utilities.

The costs include more than the cost of online search time. It takes into account such additional costs as annual fixed costs such as network membership and access fees, equipment maintenance, telephone line charges and add search charges. The search charges were figured at \$2.17 to \$2.31 per title using an average copy cataloging transaction requires 2.25 search commands.

---

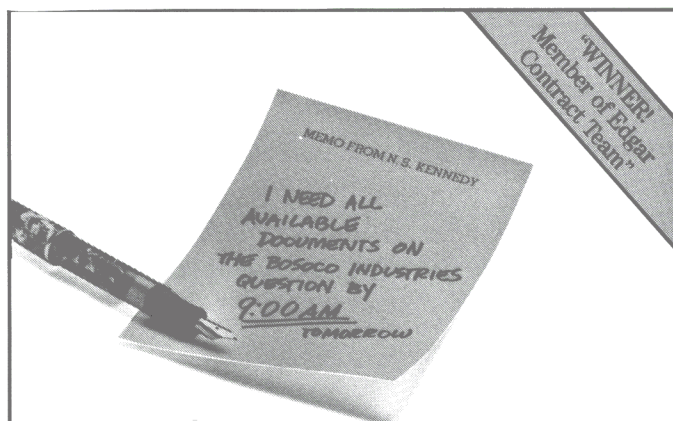

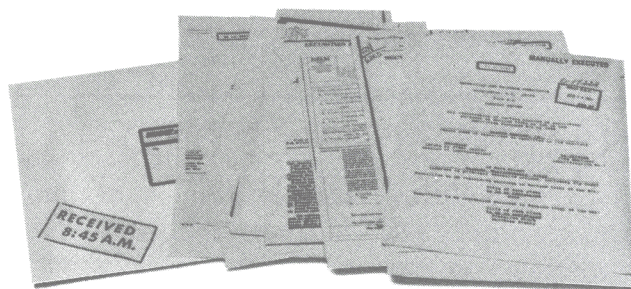
