

A COUPLE OF LAW LIBRARIANS SITTING AROUND TALKING WITH A BUNCH OF LEGAL ADMINISTRATORS

In the summer of 1991, Patricia Roux, Legal Administrator of San Francisco's Bancroft, Avery & McAlister, asked us to serve on the faculty of the Region Six Conference of the Association of Legal Administrators. The Conference was scheduled to take place during October 25-26 in Monterey. We realized that this would be a perfect opportunity to provide administrators with a comprehensive overview of the broad responsibilities we tackle every day in our firms, and we eagerly accepted Pat's offer. Our presentation was entitled "Your Library As An Administrator's Resource."

We divided our presentation into six major categories, as follows:

- (1) Marketing
 - What You Don't Know Can Hurt You. What Your Clients Don't Know Can Hurt You.
- (2) <u>Human Resources</u>
 - Surveys, Regulations, Benefits, Performance Appraisals. How Can Your Library Help? Let Us Count the Ways.
- (3) Equipment Selection
 - Hardware, Software, Furniture, Equipment ... What's Out There, and How Do You Find It?
- (4) <u>Continuing Legal Education</u>
 - Keeping Current With the Outside Courses, Developing In-House Courses, and Maintaining the Records.
- (5) <u>Conflicts of Interest</u>
 - How to Avoid the Embarrassment of Disqualification.
- (6) How to Work with Your Librarian, and What to Do if You Don't Have One

At the conclusion of the program, we distributed bibliographies (surprise, surprise) comprised of citations to articles on each of the topics we had presented.

Although we had a relatively small audience (it's difficult to compete with beautiful weather on a Saturday afternoon in Monterey), the feedback was so strong that we were invited to make the presentation again in January to the East Bay Chapter of the ALA.

Some observations? We learned that there were a number of similarities between librarians and administrators--more than we might have expected. Both groups try to keep their attorneys happy, in spite of the fact that there are often conflicting demands and

conflicting expectations. In a recent issue of Legal Management, the ALA's journal, Linda Iannelli of Altman Weil Pensa wrote:

An administrator must be careful not to place too much stock in what the lawyers say they want. In many cases, they don't know what they want, they don't want what they say they want or they want contradictory things. You didn't think it would be easy, did you?

We found the audiences to be very receptive to what we had to say to them. Both groups of ALA members asked thoughtful questions, and seemed genuinely pleased to learn about our access to resources. A number of administrators contacted us after the programs with additional requests for information. The evaluations were uniformly positive. For the administrators who already had librarians, we hope that we helped to contribute to their understanding of the role our profession can play in helping administrators do their jobs better. As for the administrators who didn't have librarians, we hope that we're now seen as terrific additions to their legal teams, rather than drains on their profits during a tight economy.

STATE LEGISLATION

Kopp Authors Measure to Restore Sales Tax Exemption to Periodicals

The Roadrunner has nothing on Senator Quentin Kopp's measure, SB 267, that would restore the exemption from sales tax to periodicals obtained through subscriptions (important to libraries). In nine days' time, the bill passed the Senate Revenue and Taxation Committee by 5 to 1, passed the Senate Appropriations Committee by 8 to 3, and passed the Senate by a 28 to 5 floor vote (1/30/92). The measure now goes to the Assembly. To monitor this important bill (some action will likely have occurred by the time you read this), call the Assembly Clerk's Office, (916) 445-3614. While California's major library associations (us included) have urged passage of this bill, the measure's success to date is undoubtedly due to effective lobbying by the State's magazine industry. Whatever works!

FYI: CLA Promoting Public Library Construction Bond Act

Your colleagues in California's public libraries and the California Library Association are asking all library professionals to support SB 1230 (Keene), the Public Library Construction Bond Act that would provide \$300 million for public library construction/renovation. FEDERAL LEGISLATION

The second session of the 102nd Congress began January 21. Of those measures introduced in the first session and significant to law libraries, one became law and four others are pending.

NREN Measure Now Law

On 1/9/91, President Bush signed into law the High-Performance Computing and Communications Act of 1991 that earmarked \$153 million (of a total \$657 million authorization) for establishment of a high-speed computer network to link government, industry and the educational community, known as the National Research and Education Network (NREN). The National Science Foundation is charged with development of NREN and with assisting colleges, universities and libraries in connecting with the network, should they be unable to connect through private sector entities. Under the new law, the private sector has responsibility for providing network connections to libraries and institutions of higher learning. Projected implementation date for NREN is 1996.

WINDO Measure Still Alive

H.R. 2772 (Rowe), the Government Printing Office Wide Information Network for Data Online (WINDO) Act of 1991, would provide a single account/gateway for a number of federal databases that contain public information. These would be accessible with no charge to depository libraries. Introduced in June of 1991, the measure remains pending before the House Administration Committee.

AALL and other major library associations support this bill.

Paperwork Reduction Act Reauthorization Stalled

Two competing Senate measures would reauthorize the Paperwork Reduction Act of 1980. S. 1139 (Nunn), favored by the Bush Administration and the small business community, focuses on "paperwork reduction" and includes provisions that would require federal agencies to consider both public and private information services and products in determining how best to disseminate information to the public. Text of the bill appears in the May 22, 1991, issue of the Congressional Record on pages S6403-11. S. 1044 (Glenn), the Federal Information Resources Management Act, would also reauthorize the Paperwork Reduction Act and would additionally revise federal information policies to (in part) assure better public access to government information. Text appears in the May 5, 1991, issue of the Congressional Record on pages S5967-74. The two bills appear to be stalled in the Senate Governmental Affairs Committee.

Both measures contain provisions re: privatization of publication of government information that are not acceptable to the library community. AALL, ALR and ALA representatives are now jointly drafting an alternative bill. OMB will likely postpone revision of Circular A-130 until compromise legislation is passed. Circular A-130 articulates existing federal information policy.

The Librarian's Bill...

H.R. 3459, authored by Major Owens (the only librarian serving in Congress), and known as the Improvement of Information Access (AII) Act of 1991, is a nifty measure that would amend the Freedom of Information Act to "improve information access" (trust a librarian to say what he means). Owens' bill would require federal agencies to: (1) disseminate government information (electronic data) in standardized record format; (2) make such information accessible through depository libraries, national networks or other channels that improve public access and provide adequate documentation, indexes and software for such information; (3) charge no more than the incremental cost of disseminating this information (no royalties); (4) publish annual reports describing their respective information policies and practices; and (5) notify the public (via the Federal Register) of any new or discontinued services. The bill is currently before the House Government Operations Committee. Text of the bill and comments by Owens are in the October 3, 1991 issue of the Congressional Record on pages E3241-45. AALL, along with other library associations, supports this measure.

TITLE 24 WHERE ARE YOU? Randy Wilson, Librarian, Sixty South Market Library

For those of you who thought you were purchasing the entire California Code of Regulations from Barclays Law Publishers, think again. Barclays is not publishing Title 24, which includes various uniform codes adopted but amended by California.

Do not get complacent because you kept the 1926 version of Title 24 published by the state. It has been superseded by the 1982 edition and the 1989 Amendments. The International Conference of Building Officials (ICBO) is now publishing it.

Just because you now know the publisher do not rest easy and think you can just call, be invoiced and have the volumes sent to you. You will need to obtain the ICBO catalog and order from the "Amendment Packets", figuring out tax and shipping costs yourself.

ICBO order desk originally instructed me to call back after January 1 1992 so that I could be sent a notice regarding the new amendments. I did as I was told. PLI BOOK ON LEGAL RESEARCH OFFERS TIPS AND STRATEGIES

PLI'S recent Commercial Law and Practice Course Handbook Series Number 590, entitled <u>Legal Research Techniques and Strategies for Associates</u>, contains source information for legal researchers in the areas of bankruptcy, environmental law, banking law, corporate securities, and legislative histories. While the book is intended to be a supplement to the PLI program, it can also be used independently as a reference manual for legal researchers in these very specific areas of the law.

The book is comprised of independent articles by 12 different contributors. The articles cover general research issues as well as specific research sources and tips. Mark Newman's article "Attorney Research Malpractice", for example, identifies cases which hold an attorney to maintain a minimum standard of research skills. As an example, he cites "Smith v. Lewis, 13 Cal 3d 349," a California Supreme Court case, which required defendant attorney to possess knowledge of the common principles of law relevant to his case. In addition, the case suggested that counsel has the burden to discover other additional rules of law as appropriate to the case. Even though this case was overruled on other grounds, the language is persuasive in establishing a standard of expected competence for attorneys.

Another article on "Cost Effective Online Searching" by Stephanie A. Heacox presents some interesting tips and strategies to reduce the costs of online searching. The suggestions lead to the expected result, namely to use an integrated approach to legal research. However, saying it and doing it are two different circumstances.

The articles on researching New York law, bankruptcy, environmental, corporate securities, and banking areas of the law all present comprehensive bibliographies of the collections of resources and their coverage for each of the specific subject areas.

The article on "A Basic Guide to Legislative Histories" by Krista Friedman sheds light on the basic components of a legislative history. She is quick to note that the researchers understanding of the "legislative process is key to identifying what documents are pertinent in researching legislative intent behind Federal statutes.

The book is replete with subject bibliographies throughout. "Good Lawyers Are Good Researchers" by Donna Heroy and Nina Wendt, appears at the end. It is worth reading as a reminder and to stir further thinking about conducting good research.

CD-ROM Lifespan Set at 3-5 Years

A recent article in New Tech News (June 10, 1991) disputes manufacturers claims that CD-ROM discs will last at least twenty years. Recent statements by the National Archives and Records Administration (NARA) have indicated that the expected lifespan is closer to three to five years. The main problem seems to be that the materials used in the manufacturing of the discs are vulnerable to breakdown in the presence of oxygen, and the production process itself allows the first oxidation to begin. Substituting a different material, such as glass for the discs would present other problems (breakage), and would not alter the need to manufacture in a costly oxygen-free atmosphere.

Libraries that have eliminated paper subscriptions based on the expectation that CD-ROM was a permanent solution might want to investigate further.

I. CHALLENGES OF PUBLIC SECTOR LAW LIBRARIANSHIP

The law librarian working in the public sector faces unique challenges. Funding sources, whether state or municipal, are usually fixed, and rarely increase to keep pace with the ever-increasing costs of legal materials. Public funding often means that staff vacancies remain unfilled for long periods, and precludes the hiring of outside temporary help. Supervising and managing staff requires a good working knowledge of public. employee law, civil service rules and any applicable union contracts. The clientele served by the public sector law librarian might be all-inclusive (for the librarian in a state or county law library) or highly specialized (for court or public agency law libraries), but most law librarians in the public sector work for an organization whose overall mission is public service. Some of these libraries are required to maintain depository collections; some collect or index items unique to their court or agency, with an obligation to maintain them as public records.

Sound familiar? The AALL State, Court and County Law Libraries Special Interest Section (SIS) is for you! As a part of AALL, its membership is drawn from public sector law librarians across the country.
