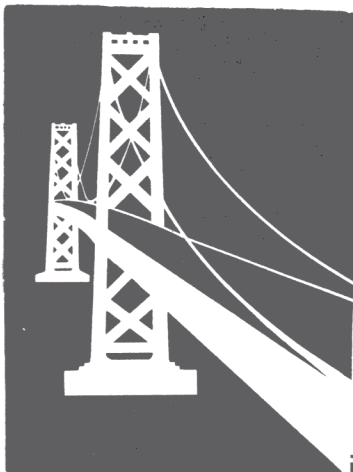

FROM THE PRESIDENT

It was nice to see so many members attend the fall business meeting. Thanks again to Marci Hoffman and Boalt for their hospitality.

Hopefully, by now, you have received your registration form for the fall workshops to be held at the Embassy Suites hotel in Walnut Creek, on November 9. We have tried to keep registration costs down, setting the fee at \$75. The program appears to have broad appeal--focusing on communications and technology. Hope to see you there!

The NOCALL directory should be out soon. Lee Ryan has been hard at work updating the database.

Several new ideas were discussed at the annual meeting:

1. The Bylaws Committee has been asked by the Board to study the possibility of the NOCALL Treasurer's position becoming a 2-year position. It is felt by Board members, past and present, that the Treasurer's job is complex and takes almost the first year to learn the job, especially filing tax returns, etc.

2. There was some discussion about whether NOCALL should have an Awards committee to recognize members for outstanding contributions each year. There was some discussion about awarding certificates, cash awards, etc. One member commented on the benefit to librarians personally and for use in their employment endeavors. Another shared

experiences about the tradition and morale booster is provided in their organization. Before moving forward or dropping the idea, I would like to know how more of the membership feels. Please let me know if you think this is an idea that you would like the Board to pursue.

3. We also discussed the idea for a Vendor Relations committee. Nora Skrukud volunteered to investigate the concept and to check with other Chapters about how this committee works in other organizations. Our focus would be on strengthening working relations with vendors, rather than the disbursement of individual complaints. Nora will give us a report on her findings at the next meeting

4. In July I asked for a volunteer to be NOCALL's AALL Liaison. Marci Hoffman has graciously agreed to accept this appointment for the remainder of the year. The purpose of the AALL Liaison is to keep the Chapter informed about what is doing at Headquarters, to send Chapter news to the AALL newsletter, and to arrange for the AALL representative's visit to us.

5. Several committee chairs attended our last Board meeting. I've extended an open invitation to committee chairs, or a representative, to attend Board meetings, which usually precede the regular business meetings. It's an opportunity for chairs to raise issues for Board discussion, to consult with the Board, and to ask the Board for guidance. I hope it will be possible for committee chairs to regularly attend Board meetings, if at all possible.

That's about it for this time. Please let me know what NOCALL can do for you.

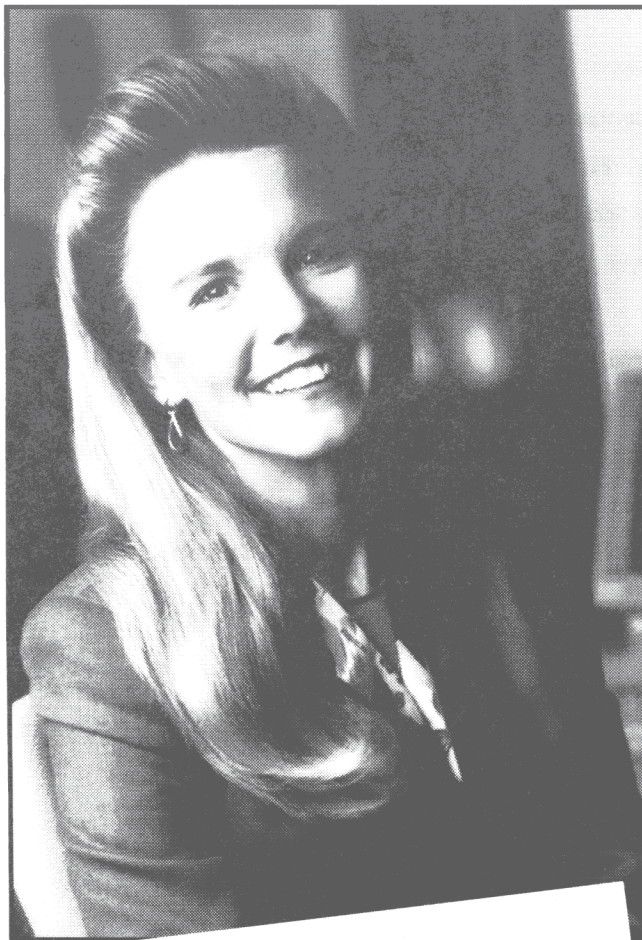

HIGHLIGHTS OF THE NOCALL EXECUTIVE BOARD

July 28, 1992

The NOCALL Executive Board met at the University of California at Berkeley, Boalt Law School. Board members present were: Judy Janes, Lee Ryan, Barbara Friedrich, Michael Jones, Lauri Flynn, Katherine Henderson, and Marci Hoffman. Judy Janes called the meeting to order at approximately 12:15 p.m.

MEETING HIGHLIGHTS

1. TREASURER'S REPORT

Barbara Friedrich submitted the Quarterly report of the Treasurer for the Fourth Quarter (March 1, 1992 - May 31, 1992). She also submitted the Annual Report of the Treasurer for Fiscal Year 1991-1992 (June 1, 1991 - May 31, 1992).

NOCALL's balance at the end of the Fourth Quarter was \$24,568.59. The balance at the beginning of the fiscal year was \$12,333.83. NOCALL's income was \$50,956.71 and the expenses were \$37,821.95.

The Board discussed the need to hire a consultant to deal with the tax issues and to complete the tax forms. It was suggested that Michael check with SCALL and AALL headquarters to see how they handle the tax issues. The Board also discussed the possibility of changing the Treasurer and Secretary positions to two years.

A MOTION WAS CARRIED to ask the Constitution & Bylaws Committee to research whether it is wise to propose an amendment to the constitution to change the positions of Secretary and Treasurer to two years.

A MOTION WAS CARRIED to approve the Treasurer's Report.

A discussion followed on the need for an audit or a resolution of the books each year. It was decided that a review of the books is needed and that there is also a need to hire someone to consult regarding tax issues.

A RESOLUTION WAS PASSED by the Board to rescind the two prior resolutions regarding an audit of the books. The Board determined that NOCALL never intended to perform a formal audit, therefore, Resolution No. 1988-7 and Resolution 1990-24 were rescinded.

A MOTION WAS CARRIED to 1) have the Audit & Budget Committee conduct a review and reconciliation of the books, similar to prior years; and 2) the Treasurer is authorized to explore retaining professional assistance in preparing and filing the tax forms.

2. 1992/1993 BUDGET PRESENTATION

The Board discussed and reviewed the proposed 1992/1993 budget.

The Board discussed reducing the registration for the workshop and the institute. Increasing the cost of the membership list was also discussed and will be looked into. The membership will be asked if they want their name on the mailing list.

A MOTION WAS CARRIED to accept the proposed budget.

A MOTION WAS CARRIED to present the budget to the membership for approval at the Fall Business Meeting, a copy of the proposed budget is attached to these minutes.

3. COMMITTEE CHAIRS AND APPOINTMENTS

Judy asked each member of the Board to come up with 3-5 names of members who might be interested in serving on a committee.

The Board discussed other ways of encouraging participation on committees. The committees with the most need are Public Relations, Education and Grants. Judy wants to increase participation in the organization.

4. PUBLIC RELATIONS COMMITTEE

The Board discussed the need for NOCALL to expand its outreach to other organizations, such as the State Bar, ABA, Legal Assistants, and Legal Administrators. The Public Relations committee is also responsible for promoting NOCALL. The Board agreed to expand this committee and also agreed that there should be representation from the Board on this committee.

5. BYLAW AMENDMENT

Judy requested that the Constitution & Bylaws Committee look into the following amendments:

- 1) changing the membership duties from the Secretary to the Membership Chair;
- 2) the quorum requirements for the Business meetings; and
- 3) changing the number of regular meetings each year from four to three.

6. CALENDAR

The Board discussed the dates and the locations for the 1992/1993 meetings. The Fall Board and Fall Business Meeting is tentatively scheduled for the week of September 14, 1992. The proposed location is UC Berkeley. The Fall workshop will be held in November. The January Business meeting is tentatively scheduled for the week of January 18th. The AALL visit is also scheduled for this meeting. The Spring Institute is scheduled for March or April. The Spring meeting is tentatively scheduled for the week of May 11th, most likely on May 13, 1993.

7. CHAPTER VISIT FROM AALL

The AALL visit will occur at the January Business meeting. Judy proposed the need for a AALL liaison from NOCALL. The purpose of a AALL liaison is to keep the chapter informed about what is going on at headquarters, send chapter news to the AALL newsletter, and arrange for the visit in January. It was the consensus of the Board to appoint someone to this position for one year.

8. NOCALL LETTERHEAD

Judy requested that Marci send each Board member a supply of letterhead and envelopes. It should also be the Secretary's responsibility to check out and maintain the chapter logos.

9. CHAPTER POST OFFICE BOX

Judy requested that Michael send money to the forwarding account at the Post Office Box, and to increase the budget if necessary.

10. WESTPAC GRANT

The Board decided to table the discussion whether to fund a WESTPAC grant and to bring it up at a Business meeting.

11. OUTSTANDING LAW LIBRARIAN AWARD

The Board deferred a full discussion of establishing such an award until the next general business meeting in order to solicit feedback from the membership.

At approximately 3:00 p.m., the meeting was adjourned.

PROPOSED AMENDMENTS TO THE BYLAWS

The following amendments to the Bylaws of the Northern California Association of Law Libraries will be presented to the membership for approval at the January 1993 business meeting:

Article II. Membership

Section 2. Dues, rights, and privileges.

Section 4. Payment of membership dues.

a. Membership dues are **due and** payable (on June 1) **at the beginning of the Association year.**

b. Members whose dues are not paid by (September 1) **the beginning of the second quarter of the Association year** shall be suspended from membership but may be reinstated upon payment of the full amount of the current year dues.

c. **Dues paid by new members who join the Association within the last quarter of the Association year will be deemed to be paid in full for membership in that quarter as well as membership for the following Association year.**

d. **New members, for the purposes of this section, shall mean any person who is eligible for membership and who has not been a member of the Association at any time during the three years preceding the current Association year in which they apply for membership.**

AUDIT AND BUDGET COMMITTEE

The Committee met with Michael Jones, NOCALL Treasurer, on Sept. 10, 1992 to audit the Treasurer's accounts for Fiscal Year 1991-1992, which closed on May 31, 1992. The Committee is satisfied that the accounts are accurate and correct.

GOVERNMENT RELATIONS COMMITTEE

We apologize for last months disjointed column. The federal legislation update was placed **in front of** the general GRC information and the state legislation update, when it was transferred from disks to the newsletter.

We would like to hear if you found useful the items we included in last months mailing: "Be a Part of The Process" and the "California Journal Roster & Government Guide".

STATE LEGISLATION

It gives me great pleasure to report some **GOOD news!**

SB 267 (KOPP) PERIODICAL SALES TAX EXEMPTION BILL was signed into law. Chapter 903 will go into effect November 1, 1992.

"Periodical" is defined as a publication that appears at stated intervals at least four times per year, but not more than sixty times per year, each issue of which contains news or information of general interest to the public, or some particular organization or group of organizations.

We wish we could say the governor signed this to help libraries. That was not the case. In his message accompanying the signing of the bill the Governor stated, "These taxes placed California businesses at a competitive disadvantage with businesses in other states. The measure will help us keep those businesses in California and retain needed jobs... The bill corrects a situation where magazine publishers in California were taxed on subscriptions, while out-of-state publishers who used out-of-state clearing houses avoided the levy."

AB 3692 (CHANDLER) BILL TO PROVIDE FUNDING FOR THE STATE LAW LIBRARY was also signed. Chapter 1149 went into effect immediately.

The State Library is in contact with the Judicial Council to arrange the amount of money the Library will be receiving and to schedule payments. The library is currently working on reinstating some subscriptions. Taking into consideration the State hiring freeze, the law library staff will be reassembled as best can be arranged. I know we are all anxious to have Muriel, Beth, Esther and others of the outstanding former law library staff back in their former positions. We'll keep you posted.

BARCLAYS, OFFICE OF ADMINISTRATIVE LAW, AND THE CCR

John Smith, Chief Deputy Director, is currently Acting director of OAL. The language in SB 1280 (the Budget Bill) proposing that funding for OAL be eliminated for 1992-93 was stricken. OAL received the same funding as last year.

OAL and Barclays are narrowing issues and will hopefully find resolutions out of court. There is a "positive spirit to settle" among the key players.

FEDERAL LEGISLATION

SUMMARY OF ACTIONS BY THE 102ND CONGRESS, SECOND SESSION

At this writing, Congress is scheduled to adjourn in three days. Of the nine Congressional measures reported on in this column, two have become law, four died in committee, and three may yet be forwarded to the President. For the most part, these measures address either the limitation or facilitation of public access to government information.

PUBLIC LAWS. The measure to provide Congress with a feasibility report re: the establishment of a Federal Online Products Catalog (FEDLINE) was signed into law in February (Public Law 102-245). Accessed through the National Technical Information Service (NTIS), Fedline is intended to strengthen the competitive position of U.S. industry by allowing access to an inventory of federal research and development data (federal agency information products and services). On 1/9/92, the President signed into law the High-Performance Computing and Communication Act of 1991 that earmarked \$153 million (of a total \$657 million authorization) for establishment of a high-speed computer network to link government, industry and the education community, known as the National Research and Education Network (NREN). The National Science Foundation is charged with development of NREN and with assisting colleges, universities and libraries in connecting with the network, should they be unable to connect through private sector entities. Senator Gore, author of NREN legislation, also introduced implementing legislation in late August. Not expected to pass this session, they will likely to be re-introduced next year.

UNFINISHED BUSINESS. Not passed by Congress was the compromise measure to grant the Library of Congress the authority to provide some fee-based products/services, S.2748 (Pell). Negotiated by representatives from LC, the library community and the information industry (and an improvement over the earlier version, S.1416), the Library of Congress Fund Act of 1992 still contained provisions problematic to library professionals. At issue was the inclusion of direct and indirect costs of distribution in calculating fees; the ambiguous criteria for "core" (no cost) and fee-based materials/services; the potential for fee-based electronic access to LC's collection. Negotiations will continue this Fall with new legislation expected next year.

Also not passed (and never expected to be) was H.R. 4426 (Barney) that would in part have amended the Copyright Act to exempt from copyright protection the volume, page, title and section numbers used to identify federal/state cases, statutes and regulations regardless of who initially assigned the identifiers (e.g., it would allow competing publishers and others to reproduce the identifiers). The measure divided the AALL membership: at issue among members was whether

the passage of H.R. 4426 would jeopardize the viability of the National Reporter System. A similar measure will likely be introduced in the next Congress.

The Electronic Freedom of Information Improvement Act of 1991, S. 1940 (Leahy), stalled after its referral to the Senate Judiciary Committee. The measure would have amended the Freedom of Information Act (FOIA) to include public access to electronic government records and to mandate that federal agencies publish electronically all information required to be published in the Federal Register. Another attempt to amend the FOIA, The Improvement of Access (AII) Act of 1991, died in the House Government Operations Committee. H.R. 3459 (Owens) would have standardized the record format of federal information stored electronically and would have made such information conveniently available to the public through depository libraries (among other improvements).

CLIFF HANGERS. Access to electronic data also figures prominently in the three key measures still alive and receiving eleventh hour attention from Congress. Two of these measures have been opposed by AALL: S. 1518 (Rockefeller) would permit federal agencies to secure copyrights on software produced by their employees; H.R. 534 (Davis) would repeal a recreational boat tax and recover the lost revenues with an access fee to users of the Federal Maritime Commission's online Tariff database.

AALL and the larger library community supported the Senate and House versions of legislation to establish through the Government Printing Office a single account/gateway for accessing a number of federal databases that contain public information (at no cost to depository libraries). Reconciliation of the GPO Wide Information Network for Data Online (WINDO) Act of 1991, H.R. 2772 (Rowe), and the Gateway to Government Act of 1992, S. 2813 (Gore), resulted in the compromise measure, H.R. 5983, pending on the Senate Calendar on 10/5/92. With two anonymous holds on the measure, its status is uncertain. The NOCALL Government Relations Committee has been in contact with certain members of Congress (Northern California Congressional Representatives, Senators and the Chair of the Senate Committee on Rules and Administration), urging passage as well.

OMB CIRCULAR A-130. The long-awaited proposed revision of OMB Circular A-130, Management of Federal Information Resources, was published in 57 Federal Register 18296 (April 29, 1992). While the revision placed less emphasis on the privatization of dissemination of government information, it excluded electronic information products from the definition of government publications made available to depository libraries. The library community (including AALL) forwarded comments/concerns to OMB in August.

Association News

AALL PUBLIC RELATIONS PROGRAM GEARS UP

AALL has launched a major public relations effort in 1992-93 in response to the Final Report of its Special Committee on Public Relations issued in Spring 1992. The Executive Board established a new volunteer position to spearhead this effort, the Public Relations Coordinator, and created a new Public Relations Advisory Committee to provide guidance and support. It also provided a significant budget, perhaps the best indicator of how important they consider an effective public relations program to be.

While some of the specifics of the program can only be developed in response to particular needs as they arise, the primary goal is already clear: **top inform a variety of audiences that because of unique education, training, and experience, law librarians are the professionals best able to provide, or coordinate access to, legal information.** Among the audiences targeted to receive this and many related messages are hiring and funding authorities (e.g., law firm administrators, law school deans, county law library boards of trustees), library patrons, non-law librarians and other information professionals, library educators, and students.

To reach these diverse groups, it is necessary to call upon all the resources available to AALL. And our most important resource by far is the membership itself. Each and every member should be a part of AALL's public relations "team." Headquarters personnel can issue news releases, develop marketing campaigns, and engage in like-scale activities, but they cannot personally interact with those in our target audiences as can librarians who encounter them on a daily basis. These direct contacts are perfect windows of "PR opportunity" **if** we are prepared to take advantage of them. One of the major goals of the AALL program will be to provide information and support to ensure such preparation exists. Brochures, press packets, posters, informational handouts, exhibit booths, and sample marketing tools are just a few of the tangible items which will be available to members. Perhaps more important will be the provision of **ideas and practical suggestions** which can be turned into successful promotional devices in each and every law library.

So what does all this mean for you? At the moment, not much. A wide-ranging program such as envisioned here does not occur overnight. But you will see tangible evidence as the year progresses, including a monthly column in the AALL Newsletter entitled "PR Potpourri" which will be filled with tips and suggestions that are "ready for use." And here's where you can help. We are looking for public relations successes--be they large, small, or medium-sized--which can be reported to readers of the column. Sharing your methods in this way might jumpstart someone into an activity that spreads the word about law librarians and thus ultimately is as much to your benefit as to theirs.

So be it a bookmark, a clever poster or brochure, a special program, or an article you wrote, please contact me with news of your PR efforts so that I may share them with our colleagues. All I need is a brief description and/or an actual sample, if appropriate. I am also interested in any thoughts or ideas you may have about the AALL Public Relations program generally. I look forward to hearing from you all.

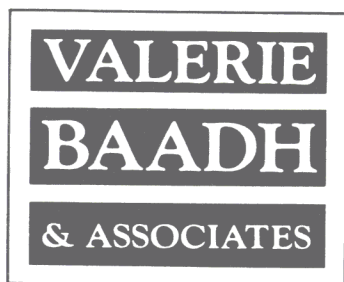
Association News

ASSOCIATION POLICY ON MAILING LISTS RELATED TO ELECTIONS

The AALL Executive Board adopted the following resolution on July 5, 1986:

"The use of all Association publications, including those published by the Special Interest Sections, for the promotion of candidates for election to the Executive Board, either by reference in an article or by means of paid advertising is prohibited. Neither shall the membership list of the Association or that of Special Interest Sections be sold or given to any individual or group or used by them for the promotion of candidates for election to the Executive Board"

When this policy was adopted, the Council of Chapter Presidents agreed that Chapters should also abide by it. In order to insure accurate and equal coverage of all candidates for election, the December Newsletter will feature candidates' photographs, biographical sketches and personal statements prior to balloting by the membership.

The following is the report of the NOCALL Membership Committee that was submitted at the NOCALL Fall Business Meeting, Thursday, September 17, 1992

Renewals

The major activity of the committee so far this fiscal year has been handling the 1992/93 membership renewals. Of 421 members from 1991/92, 327 (or about 78 %) have renewed for this year; 62 active members, 17 associate members, 13 student members and one retired member have yet to renew their membership.
