#### HIGHLIGHTS OF THE BOARD MEETING July 25, 1994

- 1. The minutes of the previous meeting were approved.
- 2. The Treasurer's Report for June 1 July 25 1994 was approved. It showed a beginning balance of \$16,682.65, income of \$18,947.78, expenses of \$3,775.18, and an ending balance of \$31,855.25.
- 3. The Audit and Budget Committee presented their report, which showed a discrepancy between the Treasurer's Report and the report of the outside auditor, attributed to checkbook balances and quarterly report figures. The committee presented a budget for 1994-95 that contains a \$9454.00 deficit. The board postponed approval of this budget, pending further consideration at a meeting on August 19 and efforts on the part of all committees to reduce their expenses and suggest sources for income.
- 4. Each board member will serve as liaison to several committees to improve communication with the membership. the assignments are:

Todd Bennett: AALL Liaison, Constitution & Bylaws, Education, Union List, Placement

Lauri Flynn: Archives, Grants, Public Access

Donna Hughes-Oldenburg: Audit & Budget, Library School Liaison, Membership, public Relations

Nancy Adams: Consulting, Internet, Newsletter, Nominations

Donna Purvis: Government Relations, Spring Institute

The committee chairs are being asked to prepare a statement of goals and objectives for the September Business Meeting

- 5. The Annual Meeting was tentatively scheduled for Thursday, May 11, 1995. The Fall business Meeting will be on Thursday, September 22, 1994. Locations for both will be determined. The board is also considering holding at 15th anniversary dinner for NOCALL.
- 6. President Todd Bennett proposed adding two members at large to the board to increase participation by the membership. He will research this concept with other chapters and report.
- 7. It was agreed to try to offer MCLE credit under the auspices of employers who are already providers. No one has an estimate as to how many of our members are members of the bar and in need of MCLE credits.

How Do I Get to the NOCALL and Buddies Web Server and See All These Goodies? The URL for the NOCALL/Buddies Server is:

On Netcom, CLASS, or any other system with access to the UNIX shell, type in the following at your system prompt (e.g., class%, netcom):

lynx ftp://ftp.netcom.com/pub/loftus/nocall/home.html

If you can't get to a system prompt on your service, follow these telnet instructions to access the NOCALL/Buddies Server: telnet acc.wuacc.edu/login as: lawnet/choose the unofficial menu/choose AALL Chapters (NOCALL, etc)/choose NOCALL.

If you've never used lynx before, type H when you get into the menu to see the keystroke commands.

Do I Have to Type That "lynx ftp://ftp.netcom.com" Thing Every Time? No, you can set up an alias for it. At your system prompt, type in: pico .cshrc

Cursor to the bottom of the file and type all of the following in one line: alias nocall 'lynx ftp://ftp.netcom.com/pub/loftus/nocall/home.html'

Press the Ctrl X keys to save the file. Hit the y key to save the modified buffer. Hit the enter key to name the file .cshrc.

You need to log out of your service for the change to take effect. When you sign in again, type nocall at the system prompt and you will go directly into the NOCALL/Buddies Server.

I would like to take this opportunity to thank Nancy Hoebelheinrich for the exemplary job she has done as Chair of the Government Relations Committee. The Committee's annual report which appeared in the last number of this publication detailed for the members the active program which the Committee pursued under Nancy's leadership.

As the Committee Chair for this year, I hope to build on the discussions that were begun last year. The Committee has wrestled with questions relative to the form and content of the information communicated to the NOCALL membership.

The Committee's emphasis has been in monitoring federal, state and local legislation, i.e. the status of specific bills. The Committee would like to move more into an issue oriented model and discuss policy issues and impacts as well as the consequences of specific legislation.

We would like to hear what issues are of interest to the membership and we will act accordingly to address them. We are still struggling with the issue of communication - how can the Committee best hear and be heard in a timely manner. All suggestions will be entertained and all new members are especially welcome. You may contact me at the following:

#### Action Taken at the State Level:

The following is the latest update on certain California Bills that we have been monitoring:

SB 1865(Campbell) State Law Library funding. Signed by the Governor on 7-15-94

**AB 2451**(Bates) Public access to state agency information. Passed by the Senate on 8-29-94 and sent to the Assembly 8-31-94 to unfinished business.

**AB 2523**(Bowen) Master networking plan between all state agencies and the judiciary. Enrolled 8-23-94.

**AB 2524**(Bowen) State agency public records in electronic format. Passed by the Senate on 8-23-94 and sent to the Assembly on 8-23-94 to inactive file.

**AB 2525**(Bowen) Removal of disclosure exemption from state agency correspondence to the Governor. Passed by the Assembly on 6-1-94 and sent to the Senate Rules Committee failed passage on 7-5-94.

#### Action Taken at The National Level:

NOCALL GRC wrote to Senators Diane Feinstein and Barbara Boxer in regard to HR 4454 which threatened to cut \$1.5 million from the Superintendent of Documents' Salaries and Expenses budget. This money was to be used to help distribute electronic information to the Depository Library Program as mandated by PL 103-50 (Government Printing Office Electronic Information Access Enhancement Act of 1993). This bill was eventually passed on 7-22-94 and became PL 103-283, with the funding restored to \$32.2 million.

On the national level the issues to watch are the Clipper Chip, the related issue of the just proposed FBI wiretap bills, HR 4922 and S 2375, and the issue of Telecommunications/Universal Service.

The issue of Universal Service is described well in an article in September 1994 *Wired* p.102 "Universal Service" by John Browning (this article was recently posted on govdoc-l as part of a message from Victor Schribman). Some issues to consider are what services will be considered basic, how will basic services be funded, and how will regulation affect the choices available. AALL has been looking at how libraries are treated in the various bills. The bills to watch are the Markey-Fields bill (H 3636), the Brooks-Dingell bill (H 3626), and the Hollings bill (S 1086).Congressional leaders hoped to pass a bill by September, but other issues may postpone that date.

Much has been written about the Clipper Chip, but one of the best articles was in the June 12, 1994 New York Times "Battle of the Clipper Chip" by Steven Levy. There are many reasons why encryption is desirable. It could be used to make fax transmissions confidential, cellular telephone calls could be made confidential, and messages sent via computer would reach their destination without fear of being tapped. With the adoption of the Clipper Chip the only people who could decode your message are the receiver and Uncle Sam. Those on the pro side say that we need the chip to protect us from nuclear terrorists and the like, those on the con side say the loss of privacy is too large a price to pay for the slim chance of catching criminals who would be foolish enough to use encryption that could be broken by the government. There are also those who oppose Clipper because of the limits it places on the development of alternative encryption technology. We encourage you to read more about Clipper, and let your representatives know how you feel. A recent article in July/August 1994 Internet World by Mike Godwin, "A chip over my shoulder: the problems with Clipper" p.92-95, includes a box on how to get more information about Clipper (both pro and con) via the internet.



# FROM THE NEWSROOM TO THE LAW FIRM By Jane Metz, Reference Librarian McCutchen, Doyle, Brown and Enersen San Francisco

Fellow law librarians are often surprised when I tell them that my previous job was as a newspaper librarian. I'm not quite sure where this reaction comes from. I would like to flatter myself and say that they are surprised at my great talent and ability to just suddenly switch jobs and be an instant success. (I doubt it). I fear that their reaction stems from the belief that working in a law library requires special preparation and intense training in understanding the law and lawyers. (What I used to think). Or perhaps all of the law librarians I've discussed this with are so happy in their own jobs that they can't imagine being any other type of librarian. (A rather remote possibility).

For three years I worked as a librarian for the San Jose Mercury News. It was my first professional position after receiving my MLS from San Jose State. My job responsibilities at the Merc included regular reference desk hours, answering a public reference telephone line, preparing daily news articles for electronic storage at Vu/Text, and maintaining a photo archive.

How did I make the transition from a newspaper to law librarian? Very poorly at first. Or so it felt. But after the initial learning period, I began to realize that most of the differences between the two jobs were cosmetic. Even better, I learned that most of the similarities were things which had attracted me to librarianship in the first place.

#### Taking the Plunge

When Jo Caporaso, Librarian at McCutchen, interviewed me for the position of Reference Librarian, I was full of doubts. Jo had obtained my resume at the Special Libraries Association annual conference job placement center. I wondered what compelled her to call me. I had absolutely no legal background. Searching newspaper databases via Vu/Text was second nature, but I knew nothing about searching legal databases via Westlaw. I knew NEXIS, but had never ventured over to LEXIS. I decided that I was interviewing for the heck of it, and was so relaxed that I fell asleep on BART en route to the

interview. Well, I must have done something right, because a second interview and a job offer followed.

Although it is probably not wise to express doubts to the person who has just offered you a job, I revealed some of my apprehensions to Jo. She reassured me that I would learn it all. On top of that, Jo predicted that within six months I would feel completely at ease at the reference desk. I decided to take the plunge.

Plunge I did. At first it felt as though I had stepped off of a cliff. It took me months to figure out that Civil Procedure Before Trial, Schwarzer, and "the red Rutter" were all the same thing. I had a terrible time distinguishing between the courts, their rules, and the reporters. The names all sounded alike to me. The loose-leaf sets made my head spin. I kept Bieber's Dictionary of Legal Abbreviations with me at all times. At home at night, I read books on legal research. The first time a rather gruff partner became impatient with me and said, "just forget it, I'll find it myself," I felt like a complete failure. I began wondering why I ever attempted this career move.

Luckily, this baptism by fire passed quickly. I began to see patterns in the reference questions being asked. I picked up on the legal materials. I observed that a lot of the research requests were actually non-legal. Jo was right. Within six months, I felt like an old pro.

#### The Differences

The newspaper was truly an industrial plant and the work environment often reflected this. We had everyone from the mechanics who kept the delivery trucks running, to the people who sold classified advertisements, to the CEO under the same roof. Equipment-wise, the building housed everything from the presses, to the cafeteria deep fryers, to mainframe computers.

The Mercury News Library was appropriately functional, practical, and industrial in appearance. In other words, the library looked like an afterthought, a hodgepodge, and a continued on next page

dumping ground. It was housed in a virtual "leanto," on one side of the main editorial newsroom. At that time, the bulk of the library was dominated by cabinets and huge compact filing units which housed the pre-Vu/Text clippings and the photo archives. The compact units were famous for breaking down, sometimes with a spectacular show of shuddering, explosive sounds, and burning smells.

We had a library manager, seven librarians, and a library clerk crammed into these already crowded environs. My first day on the job, I was assigned a two-drawer filing cabinet and told that was where I could keep my things. It didn't even lock. I eventually graduated to a semi-private desk, wedged into a corner.

The newspaper was more or less a twentyfour hour operation, and the newsroom looked it. Some of the reporters' desks were piled so high that when you sat in the chair, a paper barricade blocked out the rest of the newsroom. Now that I think of it, perhaps that was the entire point. Reporters were also known for being food slobs. Chinese take-out containers and pizza boxes were scattered everywhere. On one occasion, a halfeaten bowl of fruit salad was left on a countertop until it fermented and began breeding flies. A Krups coffee maker had green mold growing in the carafe. Every available surface held an array of mugs, some of which looked as if they had not been washed since the Watergate story broke. The trash, the flies, and the attitude spilled over into the library.

Looking back, I do not miss the physical environment of the newspaper library at all. Now I may complain that the firm's library is poorly designed, the reference desk lay-out is awful, the collection is cramped, the coffee is bad, and my office needs better lighting. But none of it will compare with my last job.

#### The Similarities

When people ask me if working for attorneys is any different from working for reporters, I usually joke that attorneys dress better. In all reality, the reference, the end-users, and the fast pace of both types of libraries is pretty much the same.

The reference questions of reporters and lawyers are very similar. Reporters and attorneys are both often expected to become overnight experts in a company, a medical condition, or a person. They are both constantly fact-checking seemingly obscure little details. But I must admit

that the reporters' questions tended to be more "fun," often involving pop-culture. Just compare some of these real life examples of reference questions:

#### Attorney research request:

how to serve a subpoena in Russia jury verdicts re: accidental loss of limb patents for "skin patch" drug delivery systems

biography of Judge Aguilar agent for service of process at company X Reporter research request:

pictures of each republic's flag body piercing aroma-therapy biography of Jack Kerouac divine apparitions (Jesus in a tortilla)

As anyone who has ever sat at a reference desk can attest, you never know what people are going to ask you!

The library users are also very similar in both types of libraries. At the newspaper, the bulk of our users were editors, reporters, and copy clerks. But photographers, security guards, pressmen, and just plain old people off of the street wandered in. For some reason, a large percentage of the public did not understand the concept of a private corporate library. Just about every day, at least one person (usually claiming to be a long-time subscriber) would arrive at the library ready to do research. The firm library is similar with the exception of Joe Public. Either the people on the street don't know we're here or they don't care. At the firm, the bulk of our users are attorneys and legal assistants. But once again, department managers, secretaries, and mailroom clerks drop by with questions. And true to form, we help them all.

The other major similarity between the two libraries is the fast pace. Most every request seems to be a rush. Attorneys will breathlessly announce, "I have a five o'clock filing!" Stories (as newspaper articles are called) are also filed. I still find myself referring to deadlines, but the lawyers don't seem to mind. In both libraries, a necessary part of the reference interview is "When do you need this by?"

#### Overall

While I find my job at the firm both interesting and challenging, I still sometimes miss certain aspects of the newspaper. I miss continued on next page

knowing the news as it is happening, reading papers on the job, working with CNN on in the background, and unlimited online time (great for those personal research projects or settling a bet). I miss some of the reference requests: the odd-ball and the trivial. But those are just sentimental feelings, and I know switching jobs was both a

good career move and personal decision. Part of the challenge of being a librarian is rising to the occasion. I savor the notion that no matter what type of library I work in, I have the opportunity to learn something new every day. I hope this means that my job will never get boring.

# Rebecca Wendy Bass and The Future of LEXIS/NEXIS By Marlene Harmon Boalt Hall Law Library

Rebecca Wendy Bass was hired as Vice President and General Manager of Legal Information Services for Mead Data Central in November 1993. She was in Seattle in July to attend her first AALL Annual Meeting, and, not surprisingly, she spent a lot of it talking to law librarians about a subject of vital interest to many of us: the future of LEXIS/NEXIS now that Mead has put it up on the auction block.

Rebecca has a JD from Rutgers University Law School, she also attended Harvard Business School and has worked as an attorney and as a corporate executive.

In interviews conducted with chapter newsletter editors and at a LEXIS/NEXIS breakfast for academic law librarians she made it a point to reassure us that the commitment LEXIS/NEXIS has to law librarians is stronger than ever.

Rebecca described the divestiture of LEXIS/NEXIS by Mead is a "great decision", good for Mead and "excellent" for LEXIS/NEXIS and its customer base. Usually this type of sale takes 4 to 6 months. Though she gave us no hint as to who it might be, Rebecca was confident that LEXIS/NEXIS will have a significant, "more strategically focused parent" by the end of the year. Morale is high at LEXIS/NEXIS, employees are enthusiastic and positive about the future.

Rebecca was also confident that LEXIS and NEXIS will be purchased as a unit, NEXIS will not be sold separately.

She assured academic law librarians that though LEXIS/NEXIS may be re-evaluating how the money for the law school program is spent, no changes significantly limiting access and services are anticipated.

LEXIS/NEXIS is forming a new support group for law librarians, the "Information Professionals Support" (IPSG). This group is composed entirely of librarians who have MLS degrees, they will focus on the needs of law librarians. Among other things whey will serve as specialized consultants for law librarians. They will not replace customer service representatives who will continue with the responsibilities they already have.

LEXIS/NEXIS is also funding a new AALL scholarship in the memory of John R. Johnson, long time law librarian at LEXIS/NEXIS.

Legal research and the practice of law are changing. Rebecca is confident that LEXIS/NEXIS will keep up with these changes by offering a "family of product services" which, in addition to its online services, includes *LEXIS Counsel Connect*, Legal Views software built on the Folio VIEWS technology and Michie CD Rom products. She did not feel that LEXIS, with its powerful search engine, would be threatened by the increasing availability of legal material on the internet.

Rebecca Wendy Bass presented us with a picture of a LEXIS/NEXIS service dedicated to "total customer satisfaction", committed to law librarians and unaffected by the impending divestiture from Mead.
