From Southern California, Highway I-5 North:

On I-5 N, take the "J" Street / Downtown Exit  
Turn SHARP RIGHT onto 3<sup>d</sup> Street  
Turn left on Capital Mall  
Turn right on 9<sup>th</sup> Street  
Turn left on "N" Street  
Turn right on 11<sup>th</sup> Street  
Parking garage is on the left: 1517 11<sup>th</sup> Street

From North of Sacramento, Highway I-5 South:

On I-5 S, take the "J" Street / Downtown Exit  
Turn right onto 3<sup>d</sup> Street  
Turn left on Capital Mall  
Turn right on 9<sup>th</sup> Street  
Turn left on "N" Street  
Turn right on 11<sup>th</sup> Street
