whatever became of?...We had a relatively calm day a week or so ago, so I did a bit of Library housekeeping. I opened up a dusty mystery box and what did I find? Hundreds of yellow 4" by 6" checkin cards. It brought me back to the "good old days" when everything had to be checked in by hand. Even more interesting were the names of the publishers: Prentice Hall Law & Business, Clark Boardman, Ltd., Matthew Bender, Bancroft Whitney/Lawyers Cooperative, Michie, and many more. Times really have changed, haven't they?

**TROY, MICHIGAN...**Troy is a well-off Detroit suburb. The family income is high, and so is the level of education. Yet, according to an interview last year with City Manager John Szerlag, things weren't going well at all. The city was forced to cut \$22 million from the budget because the voters had refused to approve any increases in the property tax. Everything had been cut, including the Library budget. In fact, the Library had come perilously close to being shut down altogether. This is what Mr. Szerlag told The New York Times: We have zero dollars budgeted for the Library after July 1. A dedicated tax increase for the Library failed narrowly in November. It would have come to about \$100 per family. We've already stopped subscriptions. I think a library is the everyman's university. I think a lot of people who can't afford a computer use the library, and a lot of times nowadays the only way to apply for a job is through a computer. A library is also an economic development tool. When you try

to attract a business, you want your municipality to be a destination point. You don't want it to be a place where people only live and sleep. A library gives a sense of community. (Emphasis mine.)

# "There's a Bloomberg on the Rise" (apologies for the Credence Clearwater Revival pun)

It certainly appears that 2012 is going to be a very interesting year in the legal research industry. The two largest players in this market, Lexis and Westlaw, have both introduced new versions of their web-based products (namely Westlaw Next and Lexis Advance) with significant changes to both their search algorithms used for relevancy ranking and their user interfaces. will tell, however, what impact these new products will have on the market or legal research instruction. There is already some legal research scholarship suggesting that Westlaw Next may not be well suited for law school environments as it depends largely on crowdsourcing to determine relevancy (of particular note is USF Library Director Ron Wheeler's excellent article available in Law Library Journal) which puts novel legal scholarship research at a disadvantage.

Along with these technology developments, we have also recently witnessed some major financial news among these companies. For example, Thomson Reuters, the parent company of Westlaw, is reportedly having a cash crunch meeting their near-term loan obligations. One notable financial blog even placed Thomson Reuters on its list of "12 Popular Companies that Could Go Bankrupt Very Soon". Of course, financial and investing advice from a blog should always be taken with a grain of salt but it is still revealing that this market may be headed for some major developments over the next year. Additionally, West has recently announced their intention to sell off their casebook division, Foundation Press, although some

speculate that this may be due to an expected decrease in the number of law students rather than low profit-margins.

The biggest development I see on the

horizon is the emergence of Bloomberg.

Those of us in the law library community are not unfamiliar with this company. Many of us witnessed their big marketing splash at AALL back in 2008. Given that 2008 was also the peak of the financial crisis. Bloomberg may have been a victim of poor timing. Regardless, it appears that Bloomberg is making inroads into the legal research industry. According to a recent Law Library Journal article by Laura K. Justiss, already 15% of law firms are using Bloomberg as an alternative to Westlaw and Lexis for locating primary legal sources. This number will undoubtedly rise as Bloomberg continues its reportedly quite aggressive marketing plan among law students (there is news that Bloomberg is giving accounts to law schools for free and even allowing students to use these accounts over the summer). Many of us have also read about Bloomberg's recent acquisition of BNA, a company known for materials in tax, accounting, employment/labor law, bankruptcy and intellectual property. Given this acquisition, it appears that Bloomberg is trying to fill-in the "gaps" of materials it will need to truly compete with the Lexis/Westlaw duopoly. Some are even speculating that they may be preparing for a Lexis acquisition given Bloomberg's investment in a case keynumbering system.

Ultimately, it is difficult to predict what these changes will bring to legal education and legal research. Bloomberg certainly has the financial ability to "purchase" market share by offering their services and products as a "loss-leader". Regardless of how this all falls out, it appears at 2012 will indeed be an interesting year for electronic legal research.

Currently there are over fifty plaintiffs involved in the suit, with more expected, hoping to achieve class-action status in the cases. Schools involved include Golden Gate University, University of San Francisco, Albany, Cal Western and Hofstra.

Limiting our information options based on a hidden profile amounts to discrimination of the worst kind, even though the official goal of the marketers is just to get us to buy more product.

# **FALLING TOGETHER** by Marisa de los Santos

I am nearing the end of this audio book and, as in her previous two books, I find the use of language engaging and beautiful. She is one of the few authors who uses words like effervescent and who really writes the way people express emotions. How many times have you had a whole perfect conversation in your head, but said something completely different out loud?

# **CLARA AND MR. TIFFANY** by Susan Vreeland

I think this is one of Ms. Vreeland's best books. It is well written and has a wonderful artistic and creative aspect to the story. The characters are fully developed, though there are quite a lot of them, which can be hard to track. I like the juxtaposition of tolerance and intolerance expressed in this book. I also enjoyed the way the characters recreated musical evenings, bike rides (Clara calls it her 'wheel') and reading to each other from books and poetry. I like it that the characters know poetry so well that they request bits from favorite poems.

THE GOBLET OF FIRE by J. K. Rowling This is probably the third time I have read or listened to this book. While I know the story, I can enjoy the details when I read it over and over. This is a book that my son and I read together. His take on it was that nothing really happened in this book, which made me think that it was a bridge book to advance the overall story, OR, in the cynical sense of working in a law firm for many years, that Rowling had a contract for a certain number of books and needed to fulfill it.

THE DARK ENQUIRY by Deanna Raybourn This is the fourth in a series. I picked up the first as an audio book after being disgusted with another murder mystery. I needed some light reading listening and really became caught up with the characters. The murders are woven so well into the books that they are almost incidental to the relationships between the characters. The Dark Enquiry, set in England in 1889, really shows the evolution of the relationship of the two main characters, but I am not sure the reader would follow the plot without reading the first three. The audio book reader, Ellen Archer, adds so much to the characters. (I bought the print version of two of the series and really missed her inflections and tones.) I don't know if it is just the style of the author or the way people were brought up at that time, but it is so interesting to see how the characters control their body language to send a certain type of message. I don't remember reading about that in another book. Another interesting thing is the "code of conduct" that Victorian society lived by. Being a 20th/21st century person, I am having a hard time understanding the nuances of that code, so my next book may be something on Victorian etiquette!

# SCANDAL ON RINCON HILL: A SARAH WOOLSON MYSTERY by Shirley Tallman One of the traps of series books is, of course, repetition. It takes a skillful author to communicate important facts contained in previous books without being repetitive. This novel is fourth in a series about a female attorney in 1880's San Francisco. I enjoyed the previous three, but was put off by the repetition in this one. At least a quarter of the book seemed copied and pasted from previous books or from itself. Also, the strength of main character is lost in this book, as she comes across as shrill and annoying. Too bad. MRS. SCOTT: A LIFE ON SLAVERY'S FRONTIER by Lea VanderVelde
This is the incredibly intense life story of Dred Scott (full name Etheldred) and his wife, Harriet and their children.

As many people know, the *Scott v. Sanford* Supreme Court ruling is one of its most infamous. The case dragged the family through eleven years of great hardship on top of those both slave and free black people experienced in St. Louis during that time.

This book is very dense because it was so well researched. You will be very surprised to find out how their paths crossed elected officials of the high ranks; the harsh life in 1830's at Fort Snelling with the severe winters; the Missouri Compromise; detailed account of the Treaty with the Sioux and Ojibwa tribes for a large swath of Wisconsin forest; The Mexican-American War; medical practices on the frontier; and nuanced issues of social justice that have parallels in today's political arena regarding the undermining of our civil rights.

It has taken me awhile to get through it because I had to school myself on the

Missouri Compromise and other subjects of the 1850's, but it was well worth it. Above all it is an incredible story of a woman who spent her whole life fighting against more adversity than you could imagine, and who came out whole.-- *Kathleen O'Connor Lake County Law Library* 

The **DISCWORLD** series by Terry Pratchett What I learned from Terry Pratchett, prolific author of the fantasy adventure Discworld series, is that I absolutely love British humor – especially when accompanied by a wide and varied bunch of memorable characters one winds up caring about, and set in a good, fast paced story. I have now devoured most of his books (too many to count). I picked up my first at an airport last spring, entitled **CARPE JUGULUM**, and was immediately hooked. Though it is somewhere in the middle of the Discworld series, it didn't matter. Sequential reading is fine, but not necessary with his writings.

I read somewhere that before J.K. Rowling launched her Harry Potter series, the most popular author in England was Sir Terry Pratchett. I have enjoyed both. Let me know what you think. --Carolina C. Rose Legislative Research & Intent LLC
