Disruption in the Courts: Legal Tech's Role in Criminal Justice Reform

Earlier this year, the Marshall Project published an article on their web site on technology in the criminal justice system, stating that there are thirteen questions we can't answer right now because we don't have the data. Some of these questions include how many people have a criminal record, how many shootings are there in the United States, and what percentage of those eligible for parole are released. Many jurisdictions are making strides in using data analytics internally, to drive enforcement efforts and apply data science to the prosecutorial process. Emerging technologies—such as Bitcoin and blockchains—are also being used by cybercriminals as part of the dark web, but these technologies are also being heralded as the future of recordkeeping and digital file management and security. Our panelists will discuss specific projects and developments, as well as trends for the future of the role of technologists in criminal justice reform.
