I haven't read all of these but have selected those that sound interesting or fun and have acquired them all from the Internet Archive via <u>A Public Peek Into 1923</u> and the IA's link to the <u>20,000 books</u> just added.

## How You Can Keep Fit by Rudolph Valentino

Yes, the author is THAT Rudolph Valentino and this is a real exercise book. It also includes photographs of the Sheik himself, shirtless, demonstrating the exercises as well as Valentino's own philosophy of physical fitness. Whether you want to adopt the exercises into your own fitness program or just gawk at some 1920's eye candy, this book is for you!

## **ABC of Dress** by Harry Collins

This fashion book, with a handwritten note by First Lady Florence Harding for a frontispiece, tries to educate the home seamstress in the construction of tasteful clothing with a 1920's aesthetic. To my surprise, he gives instructions on getting a properly fitting corset for those women lacking a boyish figure as well as introducing concepts allowing her to design clothing for herself. He presents problems based on figure types rather than fashion and focuses on line, materials, color and texture and provides line illustrations of 1920's dresses. Get the PDF copy rather than the Kindle. Kindle lacks drawings and has many scan errors.

## Patrick Branwell Bronte by Alice Law

History has recorded Branwell Bronte as the spoiled, alcoholic brother who wasted his education and genius in the bottle. Mrs. Law takes exception to that conclusion and takes on the biographers of the Brontes to date as prejudiced and wrong. She contends that Branwell is misunderstood and may well have written part of *Wuthering Heights*, as the young man himself declared at one point. It's an interesting point of view not much espoused in these modern days. Kindle version has many errors.

## PROFESSIONAL READING IN REVIEW

"Big Data and AI: Technology, Transparency and Trust," by Marydee Ojala. *InfoToday*, Dec 2018. infotoday.com.

Librarians have been long accustomed to working with large quantities of data, including the internet, largely accessible by keyword. The age of the semantic search is dawning with the development of Al-enabled software. This article discusses the use of this type of software in legal practice, including that developed by Microsoft, Luminance and iManage. Given the almost magical results this software can deliver, information professionals often view it with distrust, especially since the workings of these applications is mostly a black box protected by intellectual property laws.

Discovery layers are now common in academic libraries, but are they working for users? The authors conducted a pilot usability study of the University of Toledo's discovery platform, EBSCO Discovery Services. Participating students were asked to perform six tasks, such as finding books locally and within the University consortium and finding journal articles. Students experienced difficulty finding books and, in the case of open-ended tasks, continued searches even when they had obtained relevant results. The task force was able to make changes in the system to solve the book-finding problem. The authors concluded that library instruction was necessary to teach students how to search using discovery layers. For libraries that have not yet adopted discovery layers, the authors suggest that usability testing should take place before implementation.

The first members of Generation Z are already entering law schools and soon will be making their way into the legal profession. This generation—born between 1995 and 2010—likely never suffered from chicken pox and view "chatting" as unconnected from talking. The author argues that law schools can more effectively reach this generation by understanding their unique characteristics, such as dependence on parents and technology, slowness in taking on adult responsibilities, and anxiety about the future. Specific suggestions for legal educators include more critical reading and writing and increased emphasis on mindfulness and self-care.

"Linkrot + Content Drift = Reference Rot: The Unintended Consequences of Digitization," by Laura Gordon-Murnane. *Online Searcher*, vol. 42, no. 6, pp. 10-17, 2018. Available via EBSCO.

How long does a webpage live? The founder of the Internet Archive estimates the average at about 100 days. Digital content cited in government documents, court opinions, and academic studies, and relied upon by decision makers may change or disappear altogether. The author details the problems of linkrot and content drift and makes specific suggestions for how librarians can advocate for and adopt preservation practices such as the Internet Archive's Save This Page tool and Harvard Law Library Innovation Lab's Perma.cc.


